Subject: First Information Report.

Sir,

I, Ankita Guha wife of Samrat Chakraborty, presently residing Radhika Apartment, 1st Floor, Rathkhola, Mathangini Hazra Road, F Siliguri District Darjeeling would like to inform you that I am the owner of a piece and parcel of land along a tin shed structure situated at Milanpa Gazal Doba having RS khatian No85, plot No 23/97, 1/96 and 19. This along with my husband Samrat Chakraborty had appointed one Kishore Chhetri son of unknown resident of Kurseong presently residing at Bot Company More Jyotnagar Siliguri as the caretaker for the purpose of looking after my plot of land as well as tin roof structure thereon and other belongings in the said premises. That on 13/7/2021 morning around 10:11 AM the said Kishore called me up and told that he is leaving and he instantly went to my plot of land along with my father Amitava Guha and Indrajit Nag and we saw that the said Kishore Chhetri had already left and had stolen all my belongings such as TV, Sound Box, Grass Chopper machine, Pump Machine, red fishes from my pond, CCTV camera and other valuables. He had also with a spiteful intention electrolysed the water in the pond by leaving a live electric wire in the pond. As a result, when my father Amitava Guha got down in the pond in search of pump machine he received electric shock and became unconscious due to the jolt. We instantly pulled him back and switched off the electric connection, that how he was saved is pertinent to mention herein, that of late my relationship with my husband got estranged and I am apprehending a deep rooted conspiracy to kill me by creating such a deadly trap. As my father was sick and bedridden and I was in great mental trauma which has precluded me from instantly lodging a written complaint.

That I therefore request you to take necessary action against Kishore Chhetri and other conspirators.
