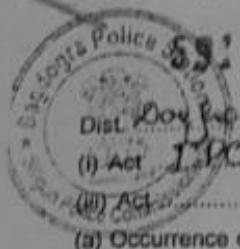

Sir,

With due respect, I SI Dipanjan Bhadra of Bagdogra PS, do hereby lodge this written complaint against the following arrested persons namely i) Sandip Das 20yrs s/o Dulal Das of Bhujipani Ramajote PS, Bagdogra Dist, Darjeeling ii) Koushik Biswas 27yrs s/o Baidyanath Biswas of Gosainpur Nutanpara PS, Bagdogra Dist, Darjeeling iii) Suman Sarkar 30yrs s/o Ashit Sarkar of Namarujote PS, Bagdogra Dist, Darjeeling iv) Kajal Biswas 28yrs s/o Pradip Biswas of Raiganj near Netaji Pathagar PS, Raiganj Dist, Uttar Dinajpur v) Rahaman Mesmul Alam 27yrs s/o Ibaidur Rahaman of Durgapur PO, Bhupalpur PS, Itahar Dist, Uttar Dinajpur vi) Asan Ali Mandal 42 yrs s/o Abdul Rahim Mandal of Gosaidubi Chat PS, Fakirgach Dist, Dhubri Assam vii) Abdur Rafik 22yrs s/o Tabarakh Ali vill: Kachan PS, Hemtabad Dist, U/ Dinajpur viii) Majarul Haque 31yrs s/o Ahammad Hussain Vill: Skulapada Kalladangi PS, Raiganj Dist, U/DNJ ix) Dipak Majumder 38yrs s/o Late Binay Majumder of Darvit PS, Islampur Dist, U/DNJ x) Kajal Kr Dev 38yrs s/o Lt. The facts of the case in brief is that today on 19/07/2021 at about 22.15 hrs in course of K-36 Night van duty vide Bagdogra PS GDE No 1084 Dated 19/07/2021 the above noted persons SI No I to III, were roaming unnecessary at **Bihar more, ti-junction** area also they did not wear face mask and SI no IV to XI was travelling by a vehicle coming from Islampur side all of the did not wear face mask as the Government of West Bengal has issued various order vide Memo no 486/CS/2021 dated 24.04.2021 that wearing of facial mask and maintain social distance made mandatory in public places in the current pandemic disaster situation all persons are to strictly comply with the COVID-19 safety norms in effect from 6 AM Sunday 16<sup>th</sup> May to shall remain 6 PM 15<sup>th</sup> June 2021 vide order No 647-ISS/2M-22/2020 dated 15.05.2021 in terms of the provisions under Disaster Management Act 2005 read with West Bengal Epidemic Disease, Covid-19 Regulations 2020 unnecessary movement shall be strictly prohibited. Accordingly, I stop them and ask to reason for not wear of face mask and roaming unnecessary but they could not give any satisfactory reason also violate against our police party. It is pertinent to note here that since the outbreak of Second wave of Corona Virus awareness regarding wearing of face mask and maintain of social distancing had been conducted through miking but the above noted persons had no botheration regarding their own safety and also the safety of others. Their act is dangerous so as to the spread of Corona Virus. Thereafter, I tried to convince them and directed to wear face mask but they denied to do so and started arguing with me. Finding no other alternative way, I apprehended them to avoid risks to human life and health.

Under the above facts and circumstances, I request you that a specific case against the aforementioned persons may kindly started with suitable sections of law.
