With due respect and in producing herewith 06 (Six) persons, namely (1) Md Asgarh (22) S/O Md Jilani of Belapur, P.O-Raily, (2) Md Wahid (20) S/O Md Niyaju of Chandoti, P.O-Alandar (3) Md Tanwir (27) S/O Ashan of Hasanpur, P.O-Belaganj, (4) Saif Alam (24) S/O Md Jahangir of Hasanpur, P.O-Belaganj, (5) Md Ashad (27) S/O Giyasuddin of Hasanpur, P.O - Belaganj, all of P.S- Belaganj, Dist. Gaya, Bihar & (6) Md Tarik (24) S/O Md Kalimuddin of Ring Road, Chak Kanthalia, Telanipara, P.S-Titagarh, Barrackpore, Dist. North 24 Parganas have been arrested by me and seized one four whalers white colour car, vehicle bearing reg no. WB 26BN 5775, KIA SONET of the following ground:

That sir, on 17/18.07.2021 during the course of Night mobile special duty myself along with force CV/131 Ranjan Sharma, CV/128 Ajay Sahani, CV/223 Swapan Chetty was performing patrolling at Methibari area under Pradhannagar PS, SPC vide PDN PS GDE No.1118 dtd.17.08.21. During patrolling I was found that one white colour car are roaming that area at about 00.35 hrs on 18.07.2021. We stop the vehicle and found that 06 (Six) person including one driver inside the said vehicle. Then I detained them and found that they are not wearing mask. On interrogation they disclosed their identity noted above and they also failed to give any satisfactory answer to roaming the area in night, which as per Govt order at 21.00 hrs to 05.00 hrs movement is restricted due to Covid 19. They refused to comply with direction of the Government regarding spreading of COVID-19. And violating the Govt. Order No. 79-CS /2020 dtd 12.04.2021 of Gove of West Bengal and Home and Hill Affairs Department of the Govt of West Bengal, vide notification number 237-I S.s /2M-24/2020 dtd 03.06.2020 and Memo no. 486-CS /2021 dtd. 24th April, 2021 of Chief Secretary & Chairman, State Executive Committee WBSDMA, Hence I arrested them u/s- 41 Cr.P.C, issuing copy of Memo of Arrest and seized the vehicle bearing reg no. WB 26BN 5775, KIA SONET informing the ground of their arrest.

Therefore, I pray before your good office that a specific case under proper section of Law may kindly be started against the above noted accused persons and arrange for its investigation.
