I, PSI Sumit Sarkar of Pradhan Nagar Police Station under Siuliguri Police
Commissionerate do here by lodge this written complaint to the effect that today i.e
19.07.2021 in between 21:30hrs to 22:00 hrs. myself along with other officers and
forces of Pradhannagar Police Station had been to Champasari more, PS-Pradhan
nagar, Darjeeling and found the above noted persons were loitering and gathered
without any proper reason .On asking the above noted persons stated before me that
they were well aware of the pandemic situation and they supposed to remain in home
and not to come out without any reason. Hence, they violated the order promulgated
by the Govt. of West Bengal for combating the spread of COVID- 19 vide order No 647-
ISS/2M-22/2020 dated 15.05.2021 and Notification number 347 -01.S.S / 2M-
24/2020 dated 3rd June, 2020 and Memo No 486-CS/2021 dated 24th April , 2021.

Accordingly, I arrested them u/s 41 Cr.P.C in c/w the above noted matter.
Hence, I request you kindly to start a specific case as per law against the above noted
arrested persons and arranged for proper investigation of the case.
