
Sir,

I, Madhurima Mandal, D/O Sri Dharendra Chandra Mondal posted as Station Manager, Pradhannagar CCC would like to inform you that one non fatal electrical accident happened at South Palash, Nutan Bazar at about 4.30 pm on 17.07.2021 where one person named Sri Subhas Dey (male), son of Sri Subodh Dey aged about 40(approx) years having address Netaji Nagar, P.O- Champasari, P.S- Pradhannagar, Pin-734003 got electrocuted.


As gathered from the local residents, the victim along with two other persons tried to fix street light at LT pole. At that time he came in contact with nearest LT conductor and an accident occurred. After getting electrocuted victim fall from ladder to ground and immediately taken to Hospital for treatment. It is also to be stated that the work was not done by WBSEDCL and such kind of activity of installation of street light to our live lines is totally illegal and it leads to unauthorized access to our electrical installments.

You are requested to please investigate into the matter and take needful action accordingly. This may please be treated as FIR.
