I, PSI Agen Lepcha of Matigara PS SPC to the effect that on 20.07.2021 during performing Mobile Van duty at Matigara Bazar under Matigara PS area he found Four persons namely (i) Niranjan Das (24), S/O Rabi Das of bagrakote, PS - SLG, Dist - DJG, (ii) Gopal Das (46), S/O Lt. Biresh Das of Uttar Samarnagar, Bou Bazar, PS - BKN, Dist - JPG, (iii) Ajay Gupta (24), S/O Lt.
