**SUBJECT: COMPLAINT AGAINST DHARAM KUMAR SINGH,
RAJEN SAHA SINGH AND PIYANSHU SINGH.**

Respected Sir,

I, **RAJEN SAHA**, S/O Late Khagen Saha, Resident of Bharatsingh
Jote, P.O. Ranidanga, District Darjeeling, PIN-734012 would like to file a
complaint against the **Dharam Kumar Singh**, Son of Rajendra Singh, Resident
of Bharatsingh Jote, P.O. Ranidanga, PIN-734012 for trying to kill me as well
as hurting me and **Rekha Singh** wife of Dharam Kumar Singh, Resident of
Bharatsingh Jote, P.O. Ranidanga, District Darjeeling, PIN-734012 for
destroying my property and threatening me and hurting me and **Piyanshu
Singh**, Son of Dharam Kumar Singh for hurting me.

That the aforesaid accused persons are my neighbors and they were
creating nuisance from the initial stage as I wanted to construct a roof at
my home.

That I also asked them to call the Panchayat and solve the matter, and
however Mr. Tapan Sarkar who was an ex Upa Pradhan of Gossainpur
area and a renowned person came to resolve the matter, but the accused
persons denied to settle on the matter.

That on 20th July 2021, however the nature of the accused persons
became violent as I was constructing a roof with my labours.

That on 20th July 2021 around 5:30pm to 6:00 pm **Dharam Kumar
Singh** broke my left hand mercilessly and also choked my neck and
whereas Dharam Kumar Singh with such intention and knowledge, and
under such circumstances attempted me merciless which could cause

me a death and also gave me a dire consequences in future , seeing this all the persons nearby came to my rescue, and thankfully I was saved from death. Not only this, the labourers who came to my rescue also got hurt by Dharam Kumar Singh in this incident.

5. That **Piyanshu Singh**, son of Dharam Kumar Singh and **Rekha Singh**, wife of Dharam Kumar Singh threw a brick on my face causing severe injury on my face as well as in my body.
6. That **Rekha Singh**, and **Dharam Kumar Singh** meanwhile, also destroyed my new built roof and also threatened me to bring men power from S.S.B. and beat me as Rekha Singh is working in S.S.B.
7. That this is not the First time, but also before Dharam Kumar Singh, Rekha Singh and Piyanshu Singh and their other relatives tried to create conflict and started fighting with me in the past.
8. That I want to file a written complaint against Mrs. Rekha Singh, Mr. Dharam Kumar Singh and Piyanshu Singh for trying to kill me, and for breaking my hand as well as for hitting me with a brick and causing severe injury in my face, and on body.
9. That I also want to file a complaint against Rekha Singh and Dharam Kumar Singh for threatening me for beating me with S.S.B. jawans causing me a great mental disturbance and also destroying my newly constructed roof.

In view of the above I beg you to file my complaint against the abovementioned accused and grant me with Justice and also oblige me.
