Subject : Forceful and Illegal activities in Violation of Status Quo order passed by Ld. Court Junior Division, Siliguri in the T.S. No: 256 of 2016. Furthermore, ongoing construction of godowns in utter violation of the relevant provisions of the West Bengal Municipal Corporation Act, 2006.

Sir,

I Bishnu Kumar Minda s/o Lt. Kanhaiyalal Minda would like to bring to your kind notice that a case i.e. T.S. No: 256/2016 is pending in the Ld. Court Junior Division, Siliguri between me and my (neighbours) other parties namely: Sarada Devi Minda, wife of Late Bansidhar Minda Satpal Minda, C/o Minda Auto Agency, Dharampal Minda, C/o Minda Agencies & Surendra Minda, C/o Tiny Tots, all sons of Late Bansidhar Minda, and all the persons mentioned herein before are residents of Ward no. XIII of the Siliguri Municipal Corporation, Sevoke Road, Siliguri, Post Office and Police station- Siliguri, District- Darjeeling, Pin-734001.

The Ld. Court Junior Division Siliguri in the above case **had passed Status Quo order** on the common passage however the neighbours are **disregarding the same & forcefully elevating passage** from both sides **by filing debris** and carrying out illegal construction on the passage since last 2 months; thus **violating the order of Ld. Court.**

It has been requested to them many times not to throw the debris on passage as it causes difficulties on easy movement, causes accident and water blockage/nuisance. Their workers also did not clear the common passage after requesting a lot and says "AMADERKE MAALIK BOLCHE EIKHANE PALATHE. TUMAR JA KORAR KORE NEO".

This is again resulting in **heavy water logging in front of my house in rainy seasons** and is illegal. It is pertinent to note that **this year** the elevation work from both sides by neighbours has been done so much that, in **half an hour of heavy rainfall** the part of passage adjacent to my house is **blocked with deep water.**

Moreover 100-150 bags of debris are kept on the passage causing difficulty in movement of vehicles and in case of emergency situations fire brigade also could not enter the passage. The above acts by neighbours are also in violation of our Family Settlement Deed and is **an illegal act causing inconvenience to me and my family members.**

Sir, the **need of emergency is to have an outlet of water blocked in front of my house** and despite of that my neighbours are elevating passage to intentionally block water in front of my house which is life threatening. They are doing unlawful activities and violating the order of Ld. Court causing disturbance in free & uninterrupted usage of the said passage.

Further please note that my neighbours through their female family members have been filing

false criminal complaints to defame and obstruct us for their wrongful gains and I don't want to indulge myself and my children in any controversy.

Furthermore, please also take note of the fact that the aforesaid persons have constructed more or less 5 to 6 godowns without any permission from the Siliguri Municipal Corporation in utter violation of the West Bengal Municipal Corporation Act, 2006 and rules framed therein. We also apprehend that the said persons are using the said godowns for storage of combustible and other prohibited substances without any requisite permission or authorisation from the relevant authority. Such acts on their part pose a serious life threat to me, my family as well as other residents of the locality.

I request your goodself to inspect the premises, take the matter in record and take all necessary legal steps against the aforesaid persons and oblige us.
