In producing herewith sex (06) arrested accused persons who disclosed their names as as (i) Gopal.Das (29 yrs) S/O- Tarapada Das of 2 No Jyotinagar Colony, Ward No-4, PS- Siliguri, Darjeeling (ii) Ashok Das (30yrs) S/O- Amar Das of 26-Dinabandhu Mitra Lane, Sukanta Nagar, Ward No-38, PS-Bhaktinagar, Jalpaiguri (iii) Enamul Hoque (28yrs) S/O- Md Muslim of Subashpally, Hatimore, Ward No-18,PS-Siliguri, Darjeeling (iv) Jagadish Barman (30yrs) S/O- Dhiren Barman of Dabgram, Sambhunath Furniture, Ward No-22, PS- Siliguri, Darjeeling (v) Biplab Sarkar (44yrs) S/O- Lt N.C. Sarkar of Netaji Pally, Ward No- 22, PS-Siliguri, Darjeeling (vi) Dhananjoy Chakraborty (35yrs) S/O- Nityananda Chakraborty of Netaji Pally, Ward No-36, PS-Bhaktinagar, Jalpaiguri. I, SI Kamal Biswas of Siliguri PS/ SPC do hereby lodge complaint against the above noted arrested persons to the effect that, on 19.07.2021 at 21.50 hrs during my Mobile Van duty myself alongwith my accompanied force had been to Venus More, Siliguri and found the above noted persons were roaming without wearing mask on their face and without any proper reasons.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and without valid movement pass issued by the local Police authority or civil administration.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021 and Order no- 713-ISS/2M-22/2020 dated 31.05.2021, Order no.753-ISS/2M-22/2020 dt.14.06.2021, 753/II-ISS/2M-22/2020 dated 28.06.2021and 753/III-ISS/2M-22/2020 dated 14.07.2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. Accourding, I arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
