Sub: Prayer causing an enquiry for the monetary fraud facing by me for getting a job in Airlines at Bagdogra.

Respected Sir,

I Swati Gloria Kujur D/O Prakash Kujur of Sailee Needem, Malbazar, Dist. Jalpaiguri and at present residing at Jiwan Tarang Apartment Lake Town, Siliguri beg to state that I had applied for a job through Quikr Job Site for Ground Duty at Airlines Bagdogra, Siliguri. Accordingly I got a phone call on 28.06.2021 by a person who introduced himself as Ashutosh Sharma of Vistara Airlines. He told me to pay Rs. 500/- for job registration so I immediately paid Rs 500/- on his account through Google Pay on 28.06.2021, he also told me to send all my qualification documents and other photo identity through Whatsaap. He again asked me to transfer Rs 3200/- for verification etc. on the same date.

On 30.06.2021 I got a mail from H.R Teamjobs <teamjobshr@gmail.com> on my name as a training letter and I had to pay Rs. 14,500/- for training purpose which I had paid through Google Pay, the said person namely Ashutosh Sharma again told me that I have to do nothing they will make all the arrangements for verification of documents and I also have to open one bank account and for all these I again paid total Rs. 23,000/-. Lastly on 3rd July 2021 the same person again told me to pay Rs. 35,000 but due to shortage of money I paid Rs. 25, 800/-. Sir I have paid the entire amount through Google Pay, now for the difference between the said money I had pay Rs. 35,000 and the sum paid by me Rs. 25,800 the person told me that all the important documents which was to be delivered to me through courier has been held at Mumbai.

Now facing such harassment I told them to cancel my application and refund my money paid to them, they told me it will be cancelled but it will take 90 days for the process. But again after few hours he again called me and pressurised to pay the remaining money and he is ready to adjust Rs. 5000/- and I have to give only Rs. 5000/-. Yesterday on 19.07.2021 he again called me and told that I have to pay 20.7% for GST to release my paid money. Sir total money paid by me is Rs. 67,000/-.

Sir now I feel I am being cheated by the person, I therefore prayer to your kind honour to kindly look into the matter and do the needful for refunding my money such fraud. For act of your kindness I shall remain ever grateful to you.
