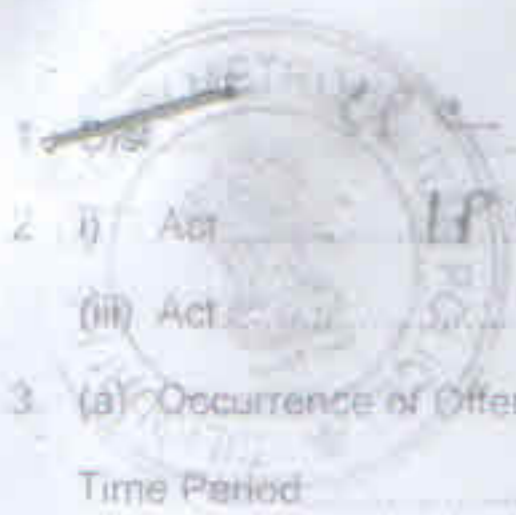

Respected Sir,

It is stated that above named Bishnu Kr. Munda and his son Abhishek Munda and Aditya Munda, resident of beside City Garden, Severe Rd, Silg, has broken his boundary wall (which was standing commonly with the common passage) and forcibly constructed various concrete casted pillars, roofs and thereon to gradually go upto the last and top floor and also encroaching and shading of the sky high eligible passage on the common passage with the fabricated shade of Tin.

Under the circumstances and at this stage the O.P is completely responsible and liable for his illegal, in lawful activities going completely against the SMC planning and Courts orders are being violated and causing the breach of peace and tranquility. So I request your good office to be kind enough to take a note of the incident in your record and do the needful into the matter as per Law.
