Sub:- Written complaint against Sabita (Sabbhu) Mahato, Mala Mahato, Dharmender Mahato, Puran Mahato, Laal Pari Devi, all are resident of Pradhannagar, Near Margaret School, P.S. Pradhannagar, Dist. Darjeeling and Rana Ghosh of Shaktigarh, P.S. NJP, Dist. Jalpaiguri and some persons of Bidhan Market Committee, under Siliguri P.S. Dist. Darjeeling.

Sir,

With due respect I, Smt. Sabitri Devi Mahato, W/o Late Nathu Mahato of 2/6, Baghajatin Colony, P.S. Pradhannagar, Dist. Darjeeling, would like to draw your kind attention to the following effect that we have joint business with Puran Mahato i.e. the elder brother of my husband as Hindu Undivided property, as a result my husband, now deceased purchased one shop in the name of Puran Mahato near about 48 years ago @ Rs. 1,500/- to Rs. 1,600/- and since then my husband used to run the said shop stall No. T/600, Gate No. 3 of Bidhan Marker, P.S. Siliguri, Dist. Darjeeling and my husband used to pay SMC Holding tax in respect of above shop regularly and after his death I am running the said shop through my staff namely Satya Narayan Roy by keeping ice from different factory through my staff and said ice are sell out among different fish merchants. I also used to pay the SMC Holding tax regularly. As a result all original tax receipts of SMC are still in our custody. Today at about 7:30 P.M. the above named persons forcibly entered into our aforesaid shop rooms and ransacked the aforesaid shop room and throw out all business materials including chair, table, stove etc. and also stolen our sale proceed approximate Rs. 5,000/-, thereafter locked our chop room under a pad-lock. The aforesaid persons also beat / assault my staff. Thereafter the aforesaid persons except Puran Mahato entered into our house and threatened me with dire consequences and Dharmender Mahato pushed me by saying that he will kill my son and torn my wearing apparels by using criminal force and outrage my modesty.


I am a ailing widow women. I use to run the aforesaid shop for my survival. Therefore you are requested to take proper step against the aforesaid persons as per Law, so as to I will again use to run the aforesaid shop for my survival.
