Sir,

In producing herewith one (01) arrested accused persons who disclosed his name and identity as Biplab Chakraborty [49 yrs] S/O- Lt. Ranendra Nath Chakraborty of Singha Para, Mekhliganj Ward No-2, PS- Mekhliganj, Dist- Cooch Behar, A/P- C/O- Smt. Rita Bhagat of Madhya Shantinagar near Usha Mike shop, PS- Bhaktinagar, Dist- Jalpaiguri. I, PSI Biswajit Sarkar of Siliguri PS/ SPC do hereby lodge complaint against the above noted arrested person to the effect that, on 22.07.2021 at 20.05 hrs during my Hotel chacking duty myself along with my accompanied force had been to Venus Hotel, Venus More, Hill Cart Road under Siliguri and found that the above noted person who also introduced himself as Maneger of said Venus Hotel intentionally refused to comply COVID-19 protocalls and Govt. orders.

On being asked, the above noted person stated before me that, he is well aware of the pandemic situation and all the orders of Government as well as local administrations regarding COVID-19.

Hence, he violated the order of Govt. of West Bengal duly promulgated in order No. 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021 and Order no- 713-ISS/2M-22/2020 dated 31.05.2021, Order no.753-ISS/2M-22/2020 dt.14.06.2021, 753/II-ISS/2M-22/2020 dated 28.06.2021 and 753/III-ISS/2M-22/2020 dated 14.07.2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the State as well as country. Accourding, I arrested him u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused person and arranged proper investigation of the case.
