In producing herewith 03 (Three) arrested accused persons U/s 41 Cr.P.C who disclosed their identity as 1) Bom Sankar Maharaj ma (36 yrs) S/o Gundeswar Maharaj of Bibadi Sangha, Bhaktinagar, PS- NJP, Dist- Jalpaiguri 2) Panu Roy (28 yrs) S/o Poatu Roy of Suryasen Colony, PS- NJP, Dist- Jalpaiguri 3) Antar Saha (18 yrs) S/o Chandan Saha of Pipeline, Bhaktinagar, PS- NJP, Dist- Jalpaiguri.


I, ASI Bhai Chandra Tamang of New Jalpaiguri Police Station, SPC do here by lodged this written complaint against the above noted persons to the effect that on 20/07/21 while performing evening mobile duty in between 18.15 hrs to 19.05 hrs, I along with forces had been to Netaji More, and found that the above noted persons were gathered there without any reason and found them without wearing mask also making unnecessary gathering at Netaji More. On being asked the above noted persons stated before me that they were well aware of Govt. order regarding pandemic situation of Covid-19 and wearing of facial mask has been mandatory in public places in the current pandemic disaster situation.

They all are violated the order of Govt. of West Bengal vide Memo No. 486-CS/2021 dt. 24.04.2021. Hence, I arrested them in c/w the case under proper memo of arrest in between 18.15 hrs to 19.05 hrs duly signed by them in presence of witnesses inform the ground of arrest.


Hence, I, request you for starting a specific case U/S 188/269/270 IPC r/w sec 51 (b) of disaster Management Act.2005 against the above noted accused persons and arrange proper investigation of the case.
