Phup Rinchey Bhutia of Ambari Falakata OP under NJP PS/SPC beg to report that on 19.07.21 in course of Night SPL mobile van duty vide Ambari OP GDE No- 639 dated on 19.07.21 myself along with force namely (1) HG 749- Nripendra Nath Sarkar (2) CV/340 Susen Roy all of Ambari-Falakata OP had been to Cannel More, Baniapara, under Ambari Falakata OP. PS. NJP to perform Night SPL mobile Van duty at 01:05hrs I found the above noted persons were roaming without face mask at that area and violated the Government Order (Lock Down) in c/w outbreak of COVID-19. Accordingly, the above noted persons were detained. On being interrogation they disclosed their identity as mentioned above and further they failed to give any satisfactory answer regarding their movement in that area rather they refuse to comply with direction of the Government Order regarding lockdown in c/w outbreak of Covid-19. Hence I arrested them u/s 41 Cr.P.C after issuing copy of Memo of arrest and inform their ground of arrest.

Therefore I pray before your good office that a specific case under proper section of Law may kindly be started against the above noted accused persons namely (1) Md.
