Respected Sir,

I Vivek Singh, Son of Mr. Mohan Singh Residence of Kamalanagar, Salugara, Near Riverview Residency, Dist: Jalpaiguri, West Bengal, 734008 would like to bring to your kind notice that on 19th July 2021 at 11 PM my brother Rahul Singh got a call from Saibo of Bedgara (Grandson of Akal Singh, Bedgara), saibo asked him to meet at Bedgara Kendra Vidyalaya back side of school ground, my brother Rahul Singh went there, and all of a sudden Saibo (Grandson of Akal Singh, Bedgara) with other 5 to 6 guys came from back and stabbed my brother continuously with a sharp Khukuri in head and over left hand side of chest, my brother Rahul Singh was carrying Rs. 8000 in cash and one Apple I phone which is also being stolen by them. On that day my brother was saved by Army personal or else they would have killed them. As per the critical condition of my brother Rahul Singh who is admitted in North Bengal Medical Hospital it is clear that the motive of Saibo (Grandson of Akal Singh, Bedgara) was to kill him. We were unable to file an FIR on 19th and 20th July as we were busy in admitting my critical condition brother in hospital.

Sir, I request you to please file an FIR against Saibo (Grandson of Akal Singh, Bedgara) with IPC Section 307 Attempt to Murder. Also sir, I request you to please accumulate my brothers Apple I phone and Rs. 8000 in Cash from them. My brother is in critical condition and required medical test and hospital expenses daily, as there is no one in the family who are capable of meeting these expenses so, sir I request you to please charge Saibo (Grandson of Akal Singh, Bedgara) with all the hospital expenses that is happening on a daily basis for my brother.
