With due respect I Smt. Susmita Dutta (Bhattacharjee), W/o. Bhaskar Dutta, presently residing in my paternal rented house situated at C/o. Mohini Mohan Sharma, Sanghati More Bazar, East Vivekananda Pally, P.O. Rabindra Sarani, P.S Bhaktinagar, Dist. Jalpaiguri, would like to inform you that, I have entered into the marriage with my husband Sri Bhaskar Dutta, S/o. Sri Kanai Dutta, of Sarada Pally, P.O Rabindra Sarani, P.S Bhaktinagar, Dist. Jalpaiguri on 20.12.2013 in a Kali Mandir at Jalpaiguri according to Hindu rites and customs. I would like to further inform you that we known each other before our marriage and from love and affection I alongwith my husband decided to married without prior permission of our parents.

I would like to further inform you that after the marriage my husband brought me in his house and we started to live together as husband and wife in my matrimonial house and after elapsing of some days my parents accept the said relation and they arranged a reception ceremony and as per the demand of my husband and his family members my father had given a cash of a sum of Rs. 30,000/- alongwith a colour T.V, Fridge, Khat, Dressing Table, Show Case, Almira and after the completion of said ceremony my husband and his parents took all the stridhan articles in their custody.

I would like to further inform you that after elapsing of marriage with a happy conjugal life I found the temperament of my husband is different, he used to physical assault me day by day. My mother in law Anita Dutta, Father In law Sri Kanai Dutta, and my husband used to physical assault me by fist and blow and most of days my husband used to have alcohol and they all together beaten me by kicking on my belly.

Thereafter I gave birth of a male child on 05.12.2015 at Siliguri Nursing home and all the expenses borne by my father even my husband denied to pay a single penny. After the birth of baby boy some days was normal but they have again started to humiliated me, my husband and in laws are very arrogant in nature and they always told me that I am a daughter of a beggar, and I have no respect from their end. My father in law was a police personnel and he always threatened me that he has a good source with police and no one can do anything against their illegal assault.

I would like to further inform you that in the month of April, 2020 when the whole country was suffered from Covid-19 pandemic and lockdown on a fateful night my husband and my in-laws started to beaten me, they used a sharp knife to kill myself and somehow I save my life from their hand and I called my parents, when they came at my maternal house they found me in a abandon condition and they thrown me out from my matrimonial house. My father took me in my paternal house and I was treated by doctors and after some days my husband came to my paternal house and felt his guilt and he took me with a promise that they will never did any type of torture upon me but after elapsing of some days they again started torture upon me by same fashion, and I further found that my husband maintain an extra marital affairs with one Nandita of Ashighar and she told me that my husband and his family members accepted the said relation as a wife of my husband and for that my husband thrown out from my paternal house and started to live together with the mercy of my parents and near relatives.

I would like to further inform you that, on 19.07.2021 my husband came to my paternal house and told me that he will took me in his house and requested me to forget everything which was happened in earlier and being an woman and with a hope that everything will be ok I went to my matrimonial house with my husband but after reaching there I became very shocked because my husband, my in laws and two neighbor namely Lipi Aunt and Rakhi pishi all together attack on me, they mercilessly beaten me, said Lipi is the aunt of Nandita and she told me that her niece will be the next bride of my husband and I have no option to enter into their house and the Rakhi Pisi told me that I have no authority to see my minor son even to touch and pressure me to sign on blank paper as my husband get divorce from court. And finding no other alternative my I called my parents and sister, and they save me from their and took me siliguri hospital for treatment and due to mental pressure and physical assault I could not file the present complaint within time.

Under the above I would like to request you to investigate the matter and do needful and punish the above named persons according to the law for the safety and security of my future and life.
