Sir,

I beg to report that on 23.07.2021 at 20.15 Hrs performing mobile duty at Old Matigara Road received source information that one Raj Kumar Biswakarma S/O Prithi Lal Biswakarma of Old Matigara road, Mahamaya Coloney, PS Matigara, Dist Darjeeling was continuously a business of ID Liquor from his house at Old Matigara Road under Matigara PS without any valid document.

At 20.45 Hrs I along with force arrived at the house of Raj Kumar Biswakarma (as pointed out by informer). On searching the house in presence of local witnesses, I found following articles/liquor inside the house of Raj Kumar Biswakarma (i) 10 (ten) bottles of King Fisher strong premium beer 650 ml each. On integration the above noted accd made different time and different statement which give enormous reason for suspicion. On asked he did not produce any valid license in favour of selling of alcohol. Then he confessed his guilt. Hence I seized ten bottles of King Fisher strong premium beer 650 ml each after preparing seizure list and label and signed by the witnesses duly signed by them he was selling Liquor without any valid document. Hence I seized the above noted articles in a proper seizure list duly signed by witnesses and arrested him after preparing arrest memo brought the same at PS for starting a specific case.

Therefore, I pray that a specific case under proper section of law may kindly be started against Raj Kumar Biswakarma S/O Prithi Lal Biswakarma of Old Matigara road, Mahamaya Coloney, PS Matigara, Dist Darjeeling.
