In producing herewith the accused person namely; Pranesh Adhikary (25) S/O
Som Prasad Adhikary of Bedgera, Ettabhati, PO Salugara, PS Bhaktinagar, Dist.
Jalpaiguri, under arrest and the following property under seizure along with seizure list

1. 143 (One hundred and forty three) bottles of Cefrex Cough Syrup, Anti allergic,
Anti Tussive, For Dry Cough Chlorpheiramine Maleate & Codeine Phosphate
cough Syrup each bottle containing 100 ml. In which chlorpheiramine Maleate 1P
4 mg. & Codeine Phosphate 1P 10 mg. contained in One brown colour cartoon
made up of paper marked as Exhibit - "A"
2. 01 (One) bottle of Cefrex Cough Syrup, Anti allergic, Anti Tussive, For Dry Cough
Chlorpheiramine Maleate & Codeine Phosphate cough Syrup each bottle
containing 100 ml. In which chlorpheiramine Maleate 1P 4 mg. & Codeine
Phosphate 1P 10 mg. Taken as Sample from Exhibit - "A" and marked as Exhibit
- "A1".

I ASI Biswajit Saha of Bhaktinagar Police Station under Siliguri Police
Commissionerate do hereby submit this report as complainant against the above noted
accused persons to the effect that today on 22/07/2021 at 21:25 hrs I received a
specific reliable source information that Pranesh Adhikary of Bedgera was coming
towards main road from Bedgera side via road near Kendriya Vidyalaya carrying a
cartoon of contraband Cough Syrup for peddling illegally to adjacent areas of Siliguri.
Accordingly, I informed the matter to I/C Bhaktinagar P.S. in written. The matter was
clarified vide Bhaktinagar P.S. G.D.E. No- 1393 date 22/07/2021. and as per his kind
direction at about 21:35 hrs myself along with ASI Bilab Kumar Das CV-619
Dharmendra Roy, CV-614 Sumit Kumar Roy of Bhaktinagar P.S. left for Salugara near
Kendriya Vidyalaya by Govt-vehicle WB-74 G 2992 to verify the veracity of the
information accompanied by my reliable source. This refers to Bhaktinagar P.S. GDE
No- 1394 date 22/07/2021. At the time of departure from the office, I took envelope,
white paper, sealing wax, gum, seal, official stamp, stamp pad and all necessary
requirements. On way to the spot at Salugara near Kendriya Vidyalaya, I called two
disinterested witnesses namely (1) Malin Chandra Roy (24) S/O- Mano Ranjan Roy of
Dakshin Palas Natun Bazar, Po. Champasari, Ps. Pradhan Nagar, Dist. Darjeeling
informed them about the information at hand. They were listening and they gave their approval in
writing.

At about 21:50 hrs. we arrived at Salugara near Kendriya Vidyalaya and parked the
vehicle at considerable distance and started ambushing at Tri junction, road towards
Bedgera and NH 31C, near Kendriya Vidyalaya, Salugara. At around 22.05 hrs, in the
faint rays of light coming from Army compound, I along with force noticed a person

coming towards NH 31 C via Bedgera Road carrying one big Cartoon on his right shoulder. I cautioned all my Police party. By the time said person reached at Tri Junction, we cordoned from all sides and apprehended and detained him. I disclosed my identity as Police Officer and also my accompanying Police team. On being asked his name and address, he disclosed his name as Pranesh Adhikary (25) S/O Som Prasad Adhikary of Bedgera, Etah, Salugara, PS Bhaktinagar, Dist: Jalpaiguri. On further grilling, he admitted that he was carrying Codeine cough syrup in the cartoon which he was carrying and was transporting the same to Salugara for selling the same to drug addicts for his wrongful gain. His admission arose strong reason to believe that the above noted person illegally possessed the prohibited cough Syrup. I gave him option notice that whether he wanted to be searched in presence of Executive Magistrate or Gazetted Officer and he agreed in writing that he did not have any objection if the search be made in presence of Gazetted Officer. Then, I requested Sri Amresh Singh, Inspector -In-Charge, of Bhaktinagar Police Station over Telephone to be present at the P.O. for the purpose of search and seizure informing the whole fact.

At 22:25 hrs Sri Amresh Singh, Inspector -In-Charge, of Bhaktinagar Police Station arrived at the P.O. and disclosed his identity to the detained person as Inspector In-Charge of Bhaktinagar Police Station under Siliguri Police Commissionerate and that he is Gazetted Officer. Thereafter, following the formalities of search and seizure in presence Sri Amresh Singh, Inspector -In-Charge, of Bhaktinagar Police Station the above two witnesses search the person of each Police personnel of our team and nothing could be found except service fire arms, wearing apparel. Then searched detained person found nothing except wearing apparel. Then, in presence and supervision of Sri Amresh Singh, Inspector -In-Charge, of Bhaktinagar Police Station and two disinterested witnesses opened the carton made up of paper and found above noted seized 144 (Forty Four) bottles of Cefrex Cough Syrup, Anti allergic, Anti Tussive, For Dry Cough Chlorpheiramine Maleate & Codeine Phosphate cough Syrup each bottle containing 100 ml. In which chlorpheiramine Maleate 1P 4 mg. & Codeine Phosphate 1P 10 mg. In presence of Gazetted officer and witnesses and Police Party demanded him valid papers / documents of said cough syrup but he could not produce. Accordingly, in presence and supervision of Gazetted Officer Sri Amresh Singh, Inspector of Police, Bhaktinagar Police Station and in presence of witnesses, I took 01 bottle of Cefrex Cough Syrup, Anti allergic, Anti Tussive, For Dry Cough Chlorpheiramine Maleate & Codeine Phosphate cough Syrup each bottle containing 100 ml. In which Chlorpheiramine Maleate 1P 4 mg. & Codeine Phosphate 1P 10 mg. as sample, sealed both the carton and sample and labelled both and marked; 143 (Forty three) bottles of Cefrex Cough Syrup, Anti allergic, Anti Tussive, For Dry Cough Chlorpheiramine Maleate & Codeine Phosphate cough Syrup each bottle containing 100 ml. In which chlorpheiramine Maleate 1P 4 mg. & Codeine Phosphate 1P 10 mg. contained in One brown colour cartoon made up of paper, as Exhibit -"A" and 01 (One) bottle of Cefrex Cough Syrup, Anti allergic, Anti Tussive, For Dry Cough Chlorpheiramine Maleate & Codeine Phosphate cough Syrup each bottle containing 100 ml. In which chlorpheiramine Maleate 1P 4 mg. & Codeine Phosphate 1P 10 mg. taken as Sample from Exhibit -"A" and marked as Exhibit -"B".

I, then, seized the above noted articles under proper seizure duly signed by the Witnesses and acknowledge by the accused Persons by putting their signatures in seizure list. The seizure was made between 22:40 hrs to 23:25 hrs. and arrested him U/S 41 CrPC informing him his ground of arrest.

On further interrogation, he admitted that he had been involved in many cases and was in Judicial Custody recently. He procured above noted Cough Syrup fraudulently and was on the way to sell the same to designed customers at Salugara and Siliguri area.

Under the above circumstances, the above accused violated the provision of NDPS Act and liable for punishment.

Hence a specific case may kindly be started against all the accused persons to meet the end of justice.
