Sir,

In producing herewith the accused person namely; Suman Sarkar @ Chindey (21) S/O Sunil Sarkar of Durga Nagar, near Kali Mandir, PS Bhaktinagar, Dist: Jalpaiguri, under arrest and the following property under seizure along with seizure list:

1. One sealed packet said to be ganja wrapped with news paper and brown colour cello tape, weighing 2 kgs.685 grms marked as Exhibit - "A".
2. One sealed envelope weighing 100 grms taken as sample from Exhibit "A", marked as Exhibit - "A-I".
3. One sealed packet said to be ganja wrapped with news paper and brown colour cello tape, weighing 2 kgs.615 grms marked as Exhibit - "B".
4. One sealed envelope weighing 100 grms taken as sample from Exhibit "b", marked as Exhibit - "B-I". ( Total Weigh 5.500grms)
5. One nylon bag in which above noted exhibits (Exhibit - "A", Exhibit - "A-I", Exhibit - "B", Exhibit - "B-I".) were contained and marked as Exhibit "C".

I ASI Rabin Lama of Bhaktinagar Police Station under Siliguri Police Commissionerate do hereby submit this written complaint against the above noted accused persons to the effect that today on 23/07/2021 at 00:25 hrs, I received a specific reliable source information that one Chindey was waiting for conveyance at Haiderpara Market Complex with Ganja for transporting the same. Accordingly, I informed the matter to I/C Bhaktinagar P.S. in written. The matter was diarized vide Bhaktinagar P.S. G.D.E. No- 1404 date 23/07/2021. and as per his kind direction at about 00:35 hrs myself along with ASI Bilab Kumar Das, CV-619 Dharmendra Roy, CV-614 Sumit Kumar Roy of Bhaktinagar P.S. left for Haiderpara Market Complex by Govt-vehicle WB-74 G 9209 to verify the veracity of the information accompanied by my reliable source. This refers to Bhaktinagar P.S. G.D.E. No- 1405 date 23/07/2021. At the time of departure from the office, I took envelope, white paper, sealing wax, gum, seal, official stamp, stamp pad and all necessary requirements. On way to the spot at Haiderpara Market complex, I called two disinterested witnesses namely (1) Suman Saha (33) S/O Sukumar Saha of Ghugumali, near Kalisaha More, Ward No. 37, PS Bhaktinagar, Dist. Jalpaiguri and (2) Sri. Swapan Goswami (41) S/O Sankar Goswami of Hatiyadanga, Near Jr. High School, PS Bhaktinagar, Dist. Jalpaiguri and informed them about the information at hand in writing and they gave their approval in writing.

At about 00:45 hrs. we arrived at near Haiderpara Market Complex and apprehended one person who was holding one plastic bag. I disclosed my identity as Police Officer and of my entire accompanying Police team. On being asked he disclosed his name and identity as Suman Sarkar @ Chindey (21) S/O Sunil Sarkar of Durga Nagar

near Kail Mandir, PS Bhaktinagar, Dist. Silliguri. Questioned him and he admitted that he was carrying Ganja, for transporting the same to his customer for selling the same to addicts for his wrongful gain. On smelling the bag, I could smell ganja, I gave him option notice that whether he wanted to be searched in presence of Executive Magistrate or Gazetted Officer and he agreed in writing that he did not have any objection if the search be made in presence of Gazetted Officer or Executive magistrate. Then, I requested Sri Amaresh Singh, Inspector -In-Charge, of Bhaktinagar Police Station over Telephone to be present at the P.O. for the purpose of search and seizure informing the whole fact.

At 01:05 hrs Sri Amaresh Singh, Inspector -In-Charge, of Bhaktinagar Police Station arrived at the P.O. and disclosed his identity to the detained person as Inspector In- Charge of Bhaktinagar Police Station under Silliguri Police Commissionerate and a gazetted officer. Thereafter, following the formalities of search and seizure in presence Sri Amaresh Singh, Inspector -In-Charge, of Bhaktinagar Police Station and the above two witnesses searched the person of each Police personnel of our team and nothing could be found except service fire arms, wearing apparel. Then searched detained person found nothing except wearing apparel. Then, in presence and supervision of Sri Amaresh Singh, Inspector -In-Charge, of Bhaktinagar Police Station and two disinterested witnesses weighed two mother packets (1) weighing 2.785 Kgs and (2) 2.715 kgs of ganja and after opening I in presence of Gazetted officer and witnesses and Police Party demanded him valid papers / documents for possessing said Ganja but he could not produce any documents. Accordingly in presence and supervision of Gazetted Officer Sri Amaresh Singh, Inspector of Police, Bhaktinagar Police Station and in presence of witnesses, I took 100 grams as Sample form each packet and Packed and sealed and labelled two mother packets and two samples taken, all marked as noted above.

I, then, seized the above noted articles under proper seizure duly signed by the Witnesses and acknowledge by the accused persons by putting their signatures in seizure list. The seizure was made between 01:40 hrs to 02:35 hrs. and arrested him U/S 41 Cr.P.C. informing him his ground of arrest.

On further interrogation, he admitted that he had been involved in the sale of Ganja since long around Salugara area.

Under the above circumstances, the above accused violated the provision of NDPS Act and liable for punishment.

Hence a specific case may kindly be started against all the accused persons to meet the end of justice.
