In producing herewith arrested accused person namely Jhunu Roy (55) W/O Late Bimal Roy of Desbandhupara near Indoor Stadium, Ward No. 29, PS-Siliguri, Dist- Darjeeling along with seized articles vize- i) 10 ( ten ) sealed bottles of Himalayan Gold 60 up country spirit containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 100 each (Amounting of 10 x Rs 100/- =RS.1000/-) and ii) 16 ( sixteen ) sealed bottles of Himalayan Gold 60 up country spirit containing 300 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 50 each (Amounting of 16 x Rs 50/- =RS.800 /-) as per seizure list.

I, SI Uday Chakraborty of Siliguri PS, SPC do here by lodged a written complaint against above noted arrested accused person namely Jhunu Roy (55) W/O Late Bimal Roy of Desbandhupara near Indoor Stadium, Ward No.29, PS-Siliguri, Dist- Darjeeling to the effect that on 23.07.21 at 14.45 hrs while I performing Special mobile duty, I received a source information that the above noted person was busy to sale Id liquor illegally at her house situated at Deshbandhupara near Indoor Stadium, Ward No.29, under Siliguri PS in order to clandestinely dispose the same. Accordingly the fact is diarized in GD vide Siliguri PS GDE no. 1637 dated 23.07.21 and informed the fact to I/C Siliguri PS. As per direction of I/C Siliguri PS, I along with LC/1295 Swastika Rai, LCV/144 Rinki Das and CV/283 Prosenjit Dey left for Deshbandhupara near Indoor Stadium, Ward No.29, under Siliguri PS to verify the veracity of the information. On reaching at 15.05 hrs there and as identified by source cordoned the above noted area where she was selling illegal alcohol. On seeing the police party the above noted person tried to escape from the spot but we managed to apprehend the above noted person with the help of lady force and on interrogation, the above noted person disclosed her identity as noted above. On searching -- i) 10 ( ten ) sealed bottles of Himalayan Gold 60 up country spirit containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 100 each (Amounting of 10 x Rs 100/-

=RS.1000/-) and ii) 16 ( sixteen ) sealed bottles of Himalayan Gold 60 up country spirit containing 300 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 50 each (Amounting of 16 x Rs 50/- =RS.800 /-) which was kept concealed in her house. On being interrogation she could not produce any valid documents in respect of the said liquor. She also stated that she is doing this liquor business since last six (06) months approx for wrongful gain. Accordingly I seized the same in presence of witness duly signed by them. The seizure and label was made in between 15.45 hrs to 16.45 hrs. On being asked she stated that she used to sale the same to locality without any valid documents as she has violated the norms of Bengal Excise Act as such I arrested her U/S-41 Cr.P.C after observing all sorts' of rules for selling the said seized articles without any valid license.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused person Jhunu Roy (55) W/O Late Bimal Roy of Desbandhupara near Indoor Stadium, Ward No. 29, PS- Siliguri, Dist- Darjeeling along with seized articles under proper section of law and arrange for its investigate.
