In producing herewith 06 (Six) accused persons namely (1) Prabir Roy (M-21) S/O-Lt Pradip Roy of Lower Bhanu Nagar (Near Nirmal Vidya Jyoti School), Ward-42, PS-Bhaktinagar, Dist-Jalpaigui (2) Sahid Alam (M-29) S/O-Ajibuddin Alam of Gendhagachh, Daspara, PS Chopra, Uttar Dinajpur (3) Madhab Singha (M-38) S/O- Lt. Bhanu Singha @ Bhal Mahan, of Salta Bazar, Near BDO Office, PS kharibari, Darjeeling (4) Bijay Ghosh (M-21) S/O Chandan Ghosh of Dakshin Shanti Nagar, Ward-36, PS-Bhaktinagar, Dist-Jalpaigui (5) Sanjoy Ram (M-22) S/O Lt. Chotna Ram of Ranghat, Natunpara, Ward No. 05, PS- Siliguri, Dist-Darjeeling (6) Shankar Nandi (M-49) S/O Lt. I, SI Arindam Chatterjee of Panitanki Town out Post, PS- Siliguri, SPC do hereby lodge a written complaint against the above noted accused persons to the effect that on 23.07.2021 at about 17:05 hrs while performing petrolling duty at Panitanki More and found the above noted arrested persons were moving here and there without using face mask. On being asked they disclosed their name as (1) Prabir Roy (M-21) S/O-Lt Pradip Roy of Lower Bhanu Nagar (Near Nirmal Vidya Jyoti School), Ward-42, PS-Bhaktinagar, Dist-Jalpaigui (2) Sahid Alam (M-29) S/O-Ajibuddin Alam of Gendhagachh, Daspara, PS Chopra, Uttar Dinajpur (3) Madhab Singha (M-38) S/O- Lt. Bhanu Singha @ Bhal Mahan, of Salta Bazar, Near BDO Office, PS kharibari, Darjeeling (4) Bijay Ghosh (M-21) S/O Chandan Ghosh of Dakshin Shanti Nagar, Ward-36, PS-Bhaktinagar, Dist-Jalpaigui (5) Sanjoy Ram (M-22) S/O Lt. Chotna Ram of Ranghat, Natunpara, Ward No. 05, PS- Siliguri, Dist- Darjeeling (6) Shankar Nandi (M-49) S/O Lt. Bibhutibhushan Nandi of Sukanta Pally, Ward No. 31, PS- Bhaktinagar, Dist- Jalpaiguri

On interrogation, it could be learnt that they had no any reason to moving here and there without using facial mask during Pandemic disaster situation and unlock period. Over that some of the local peoples were also annoyed with the accused persons by such an act. Finding no other alternative, I arrested them U/S 41 Cr. P. C as there was no scope to give notice under 41 (A) Cr. P. C. On being asked the above noted persons stated that they were well aware of the Pandemic disaster situation and they were moving here and there without facial mask & valid reason. They negligently and malignantly move to spread infection of any decease dangerous to life during Pandemic disaster situation and unlock period.

Hence, they violated the order of Govt of West Bengal duly promulgated in order No. 753/II-ISS/2M-22/2020 and order No-753/II-ISS/2M-22/2020 dated 28/06/2021. The above noted persons have intentionally refused to comply with the order of Govt of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According, I seized the above noted vehicle and arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Under the above facts and circumstances I pray that a specific case may kindly be initiated against (1) Prabir Roy S/O-Lt Pradip Roy (2) Sahid Alam S/O-Ajibuddin Alam (3) Madhab Singha S/O- Lt. Bhanu Singha @ Bhal Mahan, (4) Bijay Ghosh S/O Chandan Ghosh (5) Sanjoy Ram S/O Lt. Chotna Ram (6) Shankar Nandi S/O Lt. Bibhuti Bhushan Nandi of Sukanta Pally, Ward No. 31, PS- Bhaktinagar, Dist- Jalpaiguri & arrange for its investigation.
