C as there was no scope to give notice under 41 (A) Cr. P. C. On being asked the above noted persons stated that they were well aware of the Pandemic disaster situation and they were moving here and there without facial mask & valid reason. They negligently and malignantly move to spread infection of any decease dangerous to life during Pandemic disaster situation and unlock period.

Hence, they violated the order of Govt of West Bengal duly promulgated in order No. 753/U-ISS/2M-22/2020 and order No-753/II-ISS/2M-22/2020 anted 28/00/2021. The above noted persons have intentionally refused to comply with the order of Govt of West Bengalæduly promulgated in view of break-out of pandemic COVID-19 throughout the country. Accounding, I seized the above noted vehicle and accested them u/s-41 Cr.P.C in c/w the case after observing all rules and formalities.

Under the above facts and circumstances I pray that a specific case may kindly be initiated against (1) Prabir Roy S/O-Lt Pradip Roy (2) Sahid Alam S/O-Ajibuddin Alam (3) Madhab Singha S/O-Lt Bhanu Singha @ Bhal Mahan. (4) Bijay Ghosh S/O Chandan Ghosh (5) Sanjoy Ram S/O Lt Chotna Ram (6) Shankar Nandi S/O Lt. Bibhuti Bhushan Nandi of Sukanta Pally, Ward No. 31, PS- Bhaktinagar, Dist-Jalpaiguri & arrange for its investigation.
