I, Sri Manoj Paul, Assistant Engineer(E) & Station Manager, Hakimpara CCC, WBSEDCL, Siliguri do here by lodge complaint against Dipak Agarwal (PH-98320 26821), S/o- Dhruva Narayan Agarwal, proprietor of Himalay Logistic, Lala Lajpat Roy Road, Ashram para, PS- Sliguri, Dist- Darjeeling for having committed offence as stated here under.

On 23.07.2021 at about 04:00 P.M. acting on a source information I, along with 1) Malay Kr. Goswami, D.E. (E), S&LP Wing, Darjeeling Region, WBSEDCL, (2) Sri Sajal Kumar Sarkar, Jr. Engineer(Gr-II), Hakimpara CCC (3) Amber Ghosh, O.E., Hakimpara CCC (4) Biswajit Ghosh, Sr. T.S.H., Hakimpara CCC and other supporting staff of Mobile van entered the commercial premises of Dipak Agarwal (PH-98320 26821), S/o- Dhruva Narayan Agarwal and inspected service installation and detected one service cable was connected from the L.T.O.H. line. During inspection it was found that the electricity is being used for commercial purpose by direct taping from LT overhead line through incoming service cable 6 sq mm single core 2-wire. It is also noted that, he is not a consumer of WBSEDCL as the electricity is being used illegally by not registering the actual electricity consumption in the meter as no meter found at the premises. The existing load found around 0.5 K.W.

As theft of electricity was detected the incoming 6 sq.mm. service wire (2 meter approx.) color blue seized by preparing a formal seizure list duly signed by the representative of Dipak Agarwal (PH-98320 26821), S/o- Dhruva Narayan Agarwal and witnesses. The copy of the seizure list handed over to the representative of Dipak Agarwal and his signature obtained as token of receipt.

As Dipak Agarwal (PH-98320 26821), S/o- Dhruva Narayan Agarwal has committed offence u/s 135(1)(a) of the Electricity Act 2003 by doing theft of electricity in the manner as stated above you are requested to take cognizance of the same by treating this complaint as FIR. The seized articles are packed and labelled by me.
