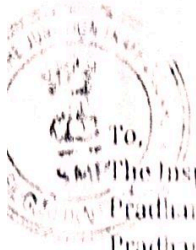

On the effect that on 22.07.2021 between 12:10 hrs. to 12.35 hrs. in course of performing Traffic regulation duty and special Naka checking at Darjeeling More, P.S Pradhan Nagar, Dist: Darjeeling vide Junction Traffic Guard, vide GDE No. 303/21 Dt: 22.07.2021 found that they were loitering here and there without wearing any Mask, which may result in the possibilities of spread of Pandemic Corona Virus, COVID-19, as the order has already been promulgated nationwide in order to combating the spread of COVID-19 vide order No. 753/III-ISS/2M-22/2020 Dated: 14.07.2021 of Chief Secretary Govt. of West Bengal, Hence they violated the said order. Finding no any alternative way, I arrested them U/S-41 Cr.PC. after proper briefed them about the ground of arrest and supplied a copy of Memo of Arrest.

Hence, I would, therefore request you to kindly start a specific Case U/S-188 IPC r/w section 51(b) of Disaster management Act 2005 against the above noted accused persons and obliged.
