I PSI Sailesh Subba of Bhaktinagar Police Station under Siliguri Police Commissionerate do here by lodge this written complaint against the above noted accused persons to the effect that on 24.07.2021 in between 17:40 Hrs to 19:35 hrs while myself along with forces of Bhaktinagar Police Station had been to Haiderpara Bazaar under Bhaktinagar PS, Dist Jalpaiguri and found the above noted persons were moving there without any reason during lockdown and not maintaining any social distancing which has been duly promulgated by Govt of West Bengal. On being asked the above noted persons stated before me that they had well aware of the pandemic situation and they supposed to remain at home and not to come out without any reason. Hence, they violated the order for combating the spread of COVID- 19 as per order of Govt of West- Bengal vide order No 647-ISS/2M-22/2020 dated 15.05.2021 and Notification number 347 -01.S.S / 2M-24/2020 dated 3<sup>rd</sup> June ,2020 and Memo No 486-CS/2021 dated 24<sup>th</sup> April , 2021 in view of break-out of pandemic COVID-19 throughout the country as well as State.

Accordingly, I arrested them u/s 41 Cr.P.C in c/w the above case. Hence, I request you for starting a specific case u/s 188/269/270 IPC R/W Sec 51 (b) Disaster Management Act, 2005 against the above noted arrested persons and arranged to proper investigation of the case.
