Bhakti Nagar, Dist Jalapiguri would like to submit that above named persons are my relatives and they are living adjacent to my house and they are constructing house building and today they are constructing Roof but during falling the mixture of sand, stone, and cement upon the roof some mixture of stone, cement, sand are falling at my house and after seeing that I told them to work properly by taking precaution more but instead of that they started shouting upon me and my family members and suddenly today i.e 24-07-2021 at about 12 P.M. all the above named accused persons entered into my house started to beat my wife and me and they hit my wife by fist and blow at random and they hit on her left eye by fist and right leg and also snatch her golden chain, and trying to outrage her modesty by pulling her maxi. As a result my wife got grievous hurt on his left eye, leg and she was admitted in Siliguri District Hospital and her condition is very serious.

Sir, I therefore request you please look into the matter and take necessary action against them by taking appropriate action.
