In producing herewith eight (08) arrested accused persons who disclosed their names as (i) Bacchu Das (30yrs) S/O- Haripada Das of Baribhasa Madani Bazar, PS-NJP, Dist-Jalpaiguri, (ii) Abinash Mandal (27yrs) S/O- Ram Padarth Mandal of New Townpara, Jalpaiguri, PS-Kotwali, Dis-Jalpaiguri, (iii) Md. Niyaz (41yrs) S/O- Abdul Jalil of Kishanganj, Tagiaria, Ward No-8, PS-Kishanganj (Behar). (iv) Biplab Naha (42yrs) S/O- Ashok Kr Naha of Dakshin Santinagar, near Kutimill, PS-Bhaktinagar, Dist-Jalpaiguri, (v) Md. Mobin (20yrs) S/O- Md. Yusuf of NJP, near IOC gate, Ward No-35, PS-NJP, Dist-Jalpaiguri, (vi) Jadip Roy (45yrs) S/O- Lt. Kukura Roy of Lower Bhanunagar, Ward No-43, PS-Bhaktinagar, Dist-Jalpaiguri, (vii) Ram Ashra Hela (54yrs) S/O- Lt. Dinag Hela of Ashrampara, Metharpatty, Ward No-13, PS-Siliguri, Dist-Darjeeling & (viii) Joydeb Mondal (45yrs) S/O- Nepal Mondal of Suryasen Colony, E-Block, near Mour Bazar, PS-Bhaktinagar, Dist-Jalpaiguri. I, SI Gopal ch. Mondal of Siliguri PS/SPC do hereby lodge complaint against the above noted arrested persons to the effect that, on 26.07.2021 at around 15.05 hrs during my R/T Mobile Van duty myself along with my accompanied force had been to Mahabirasthan, Siliguri and found that the above noted persons were roaming without wearing mask on their face and without any proper reasons.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation as well as COVID protocols and they supposed to remain in home and not to come out without any valid reason.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021 and Order no- 713-ISS/2M-22/2020 dated 31.05.2021, Order no.753-ISS/2M-22/2020 dt.14.06.2021, 753/II-ISS/2M-22/2020 dated 28.06.2021 and 753/III-ISS/2M-22/2020 dated 14.07.2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According, I arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
