In producing herewith nine (09) arrested accused persons who disclosed their names as (i) Amar Kr Prasad (31yrs) S/O- Harinarayan Prasad of South Santinagar, Binaymore, Ward No-36, PS- Bhaktinagar, Jalpaiguri (ii) Abdul Kadir (27yrs) S/O- Md Himajuddin of Bara Majlishpur, Basta, Gendabari, PS-Gowalpukur, Dist-U/DNJ (iii) Md Samir Aslam (19yrs) S/O- Lt Md Aslam of Khalparamore, Swaminagar Colony, Ward No-7, PS-Siliguri, Darjeeling (iv) Munajir Alam (23yrs) S/O- Mujafar Hussain of Adarshanagar Colony, Ward No-4, PS-Siliguri, Darjeeling (v) Goutam Das (53yrs) S/O- Lt Hare Krishna Das of Sukumar Roy Road, Subashpally, Ward No-18, PS-Siliguri, Darjeeling (vi) Ashis Sarkar (33yrs) S/O- Lt Anup Sarkar of Pukurjan, Sath Kamath, PS-Rajgaj, Jalpaiguri (vii) Ganesh Barman (36yrs) S/O- Dhiren Barman of Naukaghat, Ward No-32, PS-NJP, Jalpaiguri (viii) Titu Sutradhar (30yrs) S/O- Jayaram Sutradhar of Patiramjote, PS-Matigara, Darjeeling (ix) Debasish Banerjee (32yrs) S/O- Atul Banerjee of Lichu Bagan, Subashpally, Ward No-18, PS-Siliguri, Darjeeling. I, PSI Biswajit Sarkar of Siliguri PS/ SPC do hereby lodge complaint against the above noted arrested persons to the effect that, on 26.07.2021 at around 15.55 hrs during my R/T Mobile Van duty myself along with my accompanied force had been to Venus more, Siliguri and found that the above noted persons were roaming without wearing mask on their face and without any proper reasons.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation as well as COVID protocols and they supposed to remain in home and not to come out without any valid reason.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021 and Order no- 713-ISS/2M-22/2020 dated 31.05.2021, Order no.753-ISS/2M-22/2020 dt.14.06.2021, 753/II-ISS/2M-22/2020 dated 28.06.2021 and 753/III-ISS/2M-22/2020 dated 14.07.2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According, I arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
