Sir,

With due respect, I am producing herewith the arrested accused persons namely (i) Bappa Sahani (24 yrs) S/O late Mahendra Sahani of Sepaipara, PS- NJP, Dist.- Jalpaiguri (ii) Chetan Paswan (20 yrs) S/O late Suresh Paswan of Bansbari, Barivasa, PS- NJP, Dist.- Jalpaiguri (iii) Laltu Das S/O Chaitanya Das of Ma Babar Hat, Hatiadanga, Ashighar, PS- Bhakti Nagar, Dist.- Jalpaiguri and the following articles under seizure :-

1. One iron made Bhojali and one sharp cutting knife from the possession of accused Bappa Sahani (24 yrs) S/O late Mahendra Sahani of Sepaipara, PS- NJP, Dist.- Jalpaiguri.
2. One iron made Hasua and one iron made sabol from the possession of accused Chetan Paswan (20 yrs) S/O late Suresh Paswan of Bansbari, Barivasa, PS- NJP, Dist.- Jalpaiguri
3. One sharp cutting knife and one plastic made charger torch light and from the possession of accused Laltu Das S/O Chaitanya Das of Ma Babar Hat, Hatiadanga, Ashighar, PS- Bhakti Nagar, Dist.- Jalpaiguri

I, SI Goutam Mallik of NJP PS, Siliguri Police Commissionerate beg to state that on 26.07.21 at 01.15 hrs I received a secret source information that a gang of miscreants come to Fulbari Bazar with deadly weapons and assembled there and making preparation for committing dacoity at Fulbari area. Accordingly, I informed the fact to you as well as Asstt Commissioner of Police, East -II, SPC and diarized the fact in General diary vide NJP PS GDE No 1356 dated 26.07.21. As per kind order and direction of my superior officer myself along with ASI Khagen Barman, ASI Sajal Das, C/1053 Paresh Rava, VP/13 Jamirul Islam, VP/08 Laxman Roy and CV/306 Bisawajit Roy left for Fulbari Bazar to work out the information in hand. I also informed the fact to night RT Van officer SI Shib Shankar Das and directed him to come to Fulbari Bazar to accompany with us. At about 01.35 hrs on 26.07.21 we arrived at Fulbari Bazar. After a few time SI Shib Shankar Das along with force came to Fulbari Bazar and accompany with us. At about 01.55 hrs we found that 12/13 persons assembled in a dark place at Fulbari Bazar and they were whispering in a very low voice. Accordingly we cordoned the place properly and approach towards them very slowly and carefully. But seeing the police party they started to flee away but we the police party managed to apprehended 03 (three) of them. On interrogation the apprehended accused persons disclosed their name and identity as noted above and also disclosed that they assembled there to commit dacoity at Fulbari area.

On search of the apprehended accused persons I found (i) One iron made Bhojali and one sharp cutting knife from the possession of accused Bappa Sahani S/O late Mahendra Sahani of Sepaipara, PS- NJP, Dist.- Jalpaiguri (ii) One iron made Hasua and one iron made sabol from the possession of accused Chetan Paswan S/O late Suresh Paswan of Bansbari, Barivasa, PS- NJP, Dist.- Jalpaiguri and (iii) One sharp cutting knife and one plastic made charger torch light and from the possession of accused Laltu Das S/O Chaitanya Das of Ma Babar Hat, Hatiadanga, Ashighar, PS- Bhakti Nagar, Dist.- Jalpaiguri. During further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night. Finally they admitted their guilt and disclosed that they had assembled there and taking preparation for committing dacoity at Fulbari area. Accordingly, I seized the above noted articles under proper seizure list and arrested the above noted three accused persons under proper memo of arrest and observing all the formalities of arrest and brought them to NJP PS. The search seizure and arrest made in between 02.25 hrs and 03.05 hrs on 26.07.21.


Under the above noted fact and circumstance, I therefore pray to you that a specific case under proper section of law may kindly be started against the arrested accused persons namely (i) Bappa Sahani (24 yrs) S/O late Mahendra Sahani of Sepaipara, PS- NJP, Dist.- Jalpaiguri (ii) Chetan Paswan (20 yrs) S/O late Suresh Paswan of Bansbari, Barivasa, PS- NJP, Dist.- Jalpaiguri (iii) Laltu Das S/O Chaitanya Das of Ma Babar Hat, Hatiadanga, Ashighar, PS- Bhakti Nagar, Dist.- Jalpaiguri and arrange for its investigation.
