I, **SATRAUGHAN PRASAD**, Son of Sri Late Sakichan Prasad, presently residing at Hemanta Basu Colony, P.O & P.S. - Siliguri, Dist.- Darjeeling beg to inform you the following fact:-

1. That on **01-07-2021** at about **6.30 p.m.** some of antisocial persons namely **i) SUDHIR PASWAN, ii) RAKESH PASWAN, iii) MUKESH PASWAN, iv) MITLESH PASWAN**, all are sons of Raju Paswan and all are resident of Hemanta Basu Colony, P.O & P.S. - Siliguri, Dist.- Darjeeling enter into my house with deadly weapon and forcefully breaking the main gate of my house at aforesaid address and enter into my house and looted household article of Rs.10,000/- and when I restrain them they all started assault me with fist and blows and by kicks and when my wife came to rescue me they all outrage her modesty by using filthy and offensive languages and try to undlothe her and also try to kidnap my daughter and they all always make obstruction my way of ingress and outgress and standing their bike on my way and drinking alcohol openly so that my I am unable to came out from my house and always threatening of fear of life and to leave my house otherwise they kill me and my family members.
2. They are very dangerous and desparate in nature and my life under risk and I spend my life in very fear condition.
3. That I lodge several FIR against the above named persons but no fruitful result arises and now they threatens me that they have muscle power and have have political power so no takes any steps against them and several criminal cases pending against them.
