In producing herewith 02 (two) female accused persons namely (1) Ratna Roy (31) D/O Lt. Bijay Roy of Bidhanpally, PO- Kadamtal, PS- Matigara, Dist- Darjeeling (2) Jannat Khan (26) D/O Md. Fazrul Khan of Shiv Nagar, Near Nepali Kalyan School, Ward No. 46, PS- Pradhannagar, Dist- Darjeeling under arrest.

I, SI Arindam Chatterjee of Panitanki Town out Post, PS- Siliguri, SPC do hereby lodge a written complaint against the above noted accused persons to the effect that today on 28.07.2021 at about 12:55 hrs while myself along with ASI Biswajit Ghosh, LCV- 190 Babita Barman, LCV-175 Pratima Das, LCV- 593 Sipra Barai performing special raid duty at M Bazar, Sevoke Road and found the above noted arrested persons were open their shope (SPA) name and styled as "AVALON" with violating the Govt. Order. On being asked they disclosed their name as (1) Ratna Roy (31) D/O Lt. Bijay Roy of Bidhanpally, PO- Kadamtal, PS- Matigara, Dist- Darjeeling (2) Jannat Khan (26) D/O Md. Fazrul Khan of Shiv Nagar, Near Nepali Kalyan School, Ward No. 46, PS- Pradhannagar, Dist- Darjeeling.

On interrogation, it could be learnt that they had no any reason to open their shope (SPA) name and styled as "AVALON" with violating the Govt. Order during Pandemic disaster situation. Finding no other alternative, I arrested them U/S 41 Cr. P. C as there was no scope to give notice under 41 (A) Cr. P. C. On being asked the above noted persons stated that they were well aware of the Pandemic disaster situation and they were open their shope (SPA) name and styled as "AVALON" with violating the Govt. Order & valid reason. They negligently and malignantly move to spread infection of any decease dangerous to life during Pandemic disaster situation.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 753/II- ISS/2M-22/2020 and order No. 753/II-ISS/2M-22/2020 dated 28/06/2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. Accourding I arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Under the above facts and circumstances I pray that a specific case may kindly be initiated against (1) Ratna Roy (31) D/O Lt. Bijay Roy of Bidhanpally, PO- Kadamtal, PS- Matigara, Dist- Darjeeling (2) Jannat Khan (26) D/O Md. Fazrul Khan of Shiv Nagar, Near Nepali Kalyan School, Ward No. 46, PS- Pradhannagar, Dist- Darjeeling and arrange for its investigation.
