Siliguri, beg to inform you that my marriage was solemnized with Sri Rohan Jaiswal s/o Sri Binod Jaiswal of above noted address, nearly 02 (two) years back under Hindu Rites & Rituals, but since after my marriage, my father-in-law & mother-in-law noted below started subjecting me for physical & mental cruelty, to evict me & my husband from my matrimonial home, due to family prestige & in the hope of change in their attitudes, I did not complained against them anywhere.

But on dt. 24.07.2021 at about 11:00 PM, my father-in-law, namely (1) Binod Jaiswal s/o Lt. Ramraj Jaiswal, of above noted address entered into our home at Gangaganj noted above, in intoxicated condition and started abusing my husband in filthy languages and when I protested, my said father-in-law and my mother-in-law, namely (2) Smt. Chanda Jaiswal w/o Sri Binod Jaiswal of above noted address started beating me & my said husband with fist and blows and threatened us for dire consequences, if we will not leave our home at Ganga Nagar.

So, please take necessary actions against my above named in-laws.
