I, the undersigned, inform you as follows:

1. That I got married with Sri Anirban Chakraborty, son of Late Ashit Chakraborty, resident of Anandamayee Colony, P.O. Champasari, P.S. Pradhannagr, District: Darjeeling on 06.05.2016 at Sevoke Kalibari as per Hindu rites and ceremonies.
2. That thereafter we started to live as husband and wife at Rongpo (Sikkim) as the family members did not accept our aforesaid marriage.
3. That subsequently family members of my husband signified their willingness to accept our marriage and since they did not participate in our aforesaid marriage dated 06.05.2016, so they again got us married in their presence on 08.05.2017 at Siddeshwari Kalibari, near Indoor Stadium, Deshbandhpara, Siliguri, P.S. Siliguri, District: Darjeeling under Hindu rituals and customs.
4. That thereafter I accompanied by my husband namely Anirban Chakraborty went to my matrimonial house at Anandamayee Colony, P.O. Champasari, P.S. Pradhannagr, District: Darjeeling with all my belongings and started to live therein as husband and wife.
5. That soon after I conceived and to my utter surprise I was started to be inflicted with immense mental and physical torture by my mother-in-law namely Jharna Chakraborty at the instigation of my two sisters-in-laws namely Rupali Gharani and Dipa Chakraborty, while my husband used to remain a mere spectator.
6. That I used to be continuously rebuked with filthy languages by my in-laws, and was forced to do all household duties during such pregnancy and was even not supplied with proper diets on account of which I became feeble and weak.
7. That subsequently my mother-in-law and two sisters in-law forcibly ousted me from my matrimonial house within couple of months, retaining with them all my belongings (except gold ornaments) and I under compelling circumstances shifted to a flat at Dāgapur which belong to my husband and we both started to live therein.
8. That subsequently out of our aforesaid marriage my daughter was born on 01.02.2018 and entire expenses of nursing was borne by me as my husband was reluctant to pay the same.

- and not provide us with basic necessities of life.
10. That subsequently under the influence of my mother-in-law and two sister-in-laws, my husband started to inflict me with un-parliamentary languages everyday, upon my refusal to contribute money for the purpose of rebuilding my matrimonial house situated at Anandamayee Colony, Champasari, Siliguri and ultimately they compelled me to give them substantial amount for such rebuilding of the house as I was a working lady prior to my marriage.
 11. That thereafter my husband started to live in my above referred matrimonial house at Champasari and periodically he used to come and stay with us and during such stay he used to abuse me both physically and mentally.
 12. That on one occasion my husband under threat and force obtained my signatures on blank papers (including demi papers) as well as stamp papers.
 13. That subsequently my husband drove me away from his said flat and on and from January, 2021 I alongwith my daughter having no other alternatives started to reside in rented flat at Dagapur, but even after staying away from my husband on 18.04.2021 my mother-in-law and husband forcibly entered into my rented flat and brutally beat me with fists and blows and snatched away all my gold ornaments worth Rs 20 lakhs (approx) and went away.
 14. That at present my in-laws are constantly threatening me to transfer my land situated at Mouza: Kalkut, Pargana- Patharghata, P.S. Pradhannagar, District: Darjeeling in favour of my husband, else, they announced to kill me and my daughter.
 15. That I am passing my days in extreme fear, agony and mental trauma.

In the above circumstances, I most humbly request you to take appropriate legal action against the abovenamed persons according to law and save us from suffering further loss and injury.
