After marriage my husband always threatened me with intoxicated situation several times. I have 2 (two) childs namely Ayushka Chhetri, Date of birth 16-07-2007 & Shreya Chhetri Date of birth 04-07-2012, school going children, who are staying with me. That before 5 (Five) months ago my husband suddenly left from my house behind me alongwith two minor daughters and came to know he is at present residing at his parents house at Near Singtam Govt. Hospital, West Pendum GPU, West Pendum, East Sikkim, pin-737134. My husband were several times tortured physically & Mentally assaulted me. He never expenses maintenance since long. and threatened me remarks " Go away from my house " and my father-in-law was also always threatene me with dire consequences. I came to know, my husband at present love affiars with another unmarried daughter unknown and willing to her marry.

On the above circumstances, I, pray to your goodself, kindly taken legal action against my husband with his father, according to the court of Law.
