## Sub: FIRST INFORMATION REPORT

I have the honour to inform you that I am the owner of a flat having flat No. 6A3, In Building Complex- Barsana Garden Appartment, Khaprall Road, Mouza: Baniakhari, J.L. No. 55, P.S. Matigara, District: Darjeeling, West Bengal. Accordingly a contract Agreement was made by him on 02/04/2021 registered before the Notary Public laying down the terms and conditions for completion of work and mode of payment. That as per the contract agreement I made a cash payment of Rs.5,00,000/-( Five Lakhs) only on 02/04/2021 as advance. That in the month of May the designer asked me for giving him 20% money as agreed in the Contract agreement and I having faith on him on several occasions starting from 17/05/2021 upto 28/05/2021 have send him total amount of Rs.2,00,0001- (Two Lakhs) only in his bank account with Indian Overseas Bank bearing account number 162401000003467. Later on he again requested me to send Rs. 20000I- (Twenty Thousand) only as he was home and not keeping well.

That again in the month of June end Mr. Sambhu Joshi ask me for the payment but due to Covid-19 Lock down, I was in my home town in Dimapur, Nagaland and was unable go to Siliguri, so on hearing my inability to reach Siliguri, Mr. Sambhu Joshi told me that he has some work in Guwahati so he will come to Dimapur, Nagaland and take the amount in cash and accordingly on 11/07/2021, Mr. Sambhu Joshi arrived at Dimapur through flight from Guwahati and I accordingly gave him an amount of Rs.3,00,000/- (Three Lakhs) only in cash in that morning outside the Airport and let him sign in the Agreement and after that he
