Anichar (18), S/O Md. Abdul of Biswas Colony, near Rail gate, PS - MTG, Dist - DJG arrested u/s 41 Cr.P.C.

I, SI Subir Chowdhury of Matigara PS SPC to the effect that on 28.07.2021 while performing SPL Mobile duty under Matigara PS area found Three persons namely (i) Uttam Sha (18), S/O Dilip Sah of Tumbajote, PS - MTG, Dist - DJG, (ii) Abhishek Sah (19), S/O Mithilesh Sha of Mahamaya Colony, Ward No -47, PS - MTG, Dist - DJG, (iii) Md.
