Sir,

In producing here with twenty one arrested accused persons namely i) md. Kurban (19) s/o Md. Subhan of Dabhugiyorala Bhatgoar Colkhahia pS Kishanganj, Dist Kishanganj Bihar, ii) Uttam Kumar Singh (24) s/o Amarjit Singh of susta Mula pS-Sakra Dist-Mujafarpur bihar iii) Raj Mehta (24) s/o Sitara Mehta of Matigara Bazar PS-Matigara Dist-Darjeeling, iv) Sushil Roy (25) s/o Mahesh roy of Matigara bazaar PS-Matigara, dist-Darjeeling, v) Satyanarayan Agarwal (45) s/o Lt. Kunj bihari Agarwal of Kshudiram Pally, Stekon Road Islampur, dist-Uttar Dinajpur, vi) Rakiul Mandal (26) s/o Sri Sirajul Mandal of bhuttabari Near Khanna Hotel pS-Bagdogra Dist-Darjeeling arrested U/S 41 Cr.P.C and do hereby lodge a written complaint against them.

In this regard I beg to complain that on 28.07.2021 while performing patrolling van duty received information that some persons were loitering with out gathering mask at Siliguri Junction. I along with ASI Debasish Das, ASI Ashit Kr. Singh and force had been to Silliguri Junction and found that the above noted persons were gathering and loitering without wearing mask. They violated the order No.-647-ISS/2M-22/2020 dated 15/05/2021 and Notification number 347 - 01.S.S / 2M-24/2020 dated 3rd June, 2020 and Memo No 486-CS/2021 dated 24th April, 2021 Promulgated by Govt. of West Bengal to combat with the spread of Covid-19.

I, finding no other alternative, along with officers and force apprehended them and arrested them U/S 41C.rPC. On interrogation, they disclosed their names and address as noted above. On further grilling, they admitted that they were aware of the Lockdown Order and restrictions

imposed upon the movement of general public and vehicle to combat against the spread of Covid-19.

I, therefore, pray before you that a specific case may kindly be started against above noted arrested accused persons and take lawful action.
