In producing herewith the seized articles viz.-

- (i) 02 (two) pieces HP gas cylinder partially loaded (big domestic)
- (ii) 01 (one) piece HP gas cylinder empty (big domestic)
- (iii) 01 (one) piece rubber pipe approx length of one meter.
- (iv) 01 (one) piece gas regulator

In producing herewith above seized under proper seizure list, I SI Pradip Chakraborty of Enforcement Branch Siliguri Police Commissionerate do hereby lodge this written complaint against the sweet shop owner namely **Papai Ghosh (34) S/O Lt. Samir Ghosh, Dhobijote, PS. Bagdogra, Dist. Darjeeling** shop styled as "**Ghosh Sweets**" at Rangapani Bazar, PS. Bagdogra, Dist. Darjeeling who was illegally procured domestic HP gas cylinder and using the domestic Gas cylinder at his Sweet Shop styled as "**Ghosh Sweets**" situated at Rangapani Bazar, PS. Bagdogra, Dist. Darjeeling for commercial purpose without any valid documents or license, to the effect that today i.e. 28.07.21 at 14'05 hrs I received an information from reliable source that one **Papai Ghosh (34) S/O Lt. Samir Ghosh, Dhobijote, PS. Bagdogra, Dist. Darjeeling** styled as "**Ghosh Sweets**", at Rangapani Bazar, Bagdogra, Dist. Darjeeling has been using the domestic Gas cylinder at his Sweet Shop for use commercial purpose for his wrongful gain.

As per direction of ACP Enforcement Branch, SPC I, along with SI Goutam Kundu, ASI Ashok Biswas, C/424 Manik Roy of EB SPC left for Bagdogra PS vide EB SPC M.C.C No 91 /21 dt.28.07.2021 with stigation kit. The matters informed to Bagdogra PS vide Bagdogra PS GDE No 1552 /21 Dated 28/07/2021 along with QRT II Mobile van officer ASI Subash Ch Roy, C/269 Manik Modak and C/1103 Pankaj Sarkar of Bagdogra PS had been to Rangapani Bazar, PS- Bagdogra, Dist- Darjeeling to work out the information and apprised them about the information in hand and requested them to accompany with us during search and seizure if required and on reaching at Rangapani Bazar, PS- Bagdogra, Dist- Darjeeling we contacted with source and being shown and identify by the source I along with officers and force entered into Sweet Shop styled as "**Ghosh Sweets**" of **Papai Ghosh (34) S/O Lt. Samir Ghosh, Dhobijote, PS. Bagdogra, Dist. Darjeeling**. I found that the accused of **Papai Ghosh** was preparing sweets at his sweet shop by using the HP domestic Gas cylinder for preparing sweet at his Sweet Shop without any valid documents for commercial use on demand he could not produce any valid documents in support of using the HP cylinders for commercial use. **On seeing the Police party the shop owner namely Papai Ghosh fled away from the shop to avoid police arrest.** Further local enquiry it is revealed that the above noted accused person was using the domestic HP Gas cylinder for preparing food at his Sweet Shop as a commercial use for his wrongful gain without any valid document. I also managed independent witness namely (1) Prasanjit Pal (21) S/O Lt. Gour Pal of Tetultala, Rangapani Bazar, Dist- Darjeeling and (2) C/424 Manik Roy of Enforcement Branch SPC.

The owner of the shop **Papai Ghosh** used the domestic HP cylinder abundantly for commercial purpose. Subsequently I seized the above noted articles from the possession of his brother namely **Bubar Ghosh (32) S/O Lt. Samir Ghosh, Dhobijote, PS. Bagdogra, Dist. Darjeeling** after preparing proper seizure list and label. The seizure was made in between 15.45 hrs to 16.05 hrs)

Hence, I pray before you a specific case may kindly be started under proper section of law against the accused person **Papai Ghosh (34) S/O Lt. Samir Ghosh, Dhobijote, PS. Bagdogra, Dist. Darjeeling** and arrange for its investigation.
