Sir,

While doing preliminary enquiry of a reported electrical accident (fatal) involving victim Smt. Halema Khatun, W/O Lt. Md. Kamrul, I, Sri Sumit Koner, AE(E) & SM, Bagdogra CCC, WBSEDCL, along with Sri Rahul Karmakar (JE-II) and Sri Prasenjit Mukherjee (HA) found that the M.S angle supporting the service cable at the premise of Md. Ramjan was fixed on top of a bamboo. This bamboo was found dislocated from its position. As per information gathered from local people, the M.S. angle was shifted out of his premise while his house was being constructed and fixed on top of a bamboo. This was being done without prior permission of the office and no intimation was given to the office of the undersigned. As per WBSEDCL standards, the M.S angle was fixed inside the premises, but Md. Ramjan illegally shifted the M.S. angle out of his house.

Therefore, I would request you to lodge an F.I.R. under S/C 136/1(a) of The Indian Electricity Act and investigate the matter.
