As Government has announced wearing of facial mask has been made mandatory in public place in current pandemic disaster situation to everybody vide order no. 79-CS/2020 dated 12.04.2020, Vide memo no. 486-CS/2021 dt 24.04.2021 and also announced lock down from 16th may to 31st May vide memo no. 647-ISS/2M-22/2020 DT 15.05.2021 and the same has been extended till 15.06.2021 and order no. 753-ISS/2M-22/2020 DT 14.06.2021 and order no. 753/III-ISS/2M-22/2020 DT 14.07.2021, as it is very dangerous for
