Sir,

With due respect I, Smt.Fulrani Sarkar, wife of Late Ranjit Sarkar of Bidyachakra Colony, P.O.Sevoke Road, P.S. Bhaktinagar, Dist. Jalpaiguri hereby inform you that Smt. Dipa Sarkar W/O Sri Bibek Sarkar is my daughter and since the date of marriage my son -in-law and she are living with me in my house and Said Bibek Sarkar torturing me, my daughter and other family members of my family. That several times he used filthy languages toward all members of my family. That on 27-07-2021 at about 9-9.30 PM my said son-in-law Bibek Sarkar came to my house and showing a knife started threatening to my grant son Avi Sarkar and his other friends to kill when I protested the same said Bibek Sarkar assaulted me by kick and blow seeing the situation my son Sri Liton Sarkar came to protected me then said Bibek Sarkar brutally assaulted my son by the said knife and my son Liton Sarkar sustained several injuries to his both hands shoulder and head. Then and then some of my local person took him to the Siliguri Dist. Hospital and after proper dressing and poured medicine the Hospital authority referred him to take to the N.B.M.C & Hospital, Susrutanagar and he was admitted there in N.B.M.C.& Hospital. That today i.e. on 28-07-2021 I took him from the Hospital for further treatment that his present condition is not good and required better treatment. That due to look after the present condition of my son I could not inform the same to you on time as such some delay occurred.

That the above mentioned Bibek Sarkar is a dangerous person and several time he attacked and assaulted me and our family member.

So, therefore I am requesting you kindly to look into the matter and take appropriate legal action against the above mentioned Bibek Sarkar as early as possible.
