Sir,

In producing herewith one arrested accused person namely Sudeb Pradhan (20), S/O- Sudhansu Pradhan of Patiram Jote, P.S- Matigara, Dist- Darjeeling along with one loaded Shaktimaan Truck bearing plate no- WB-76/8206 loaded with River bed materials, Sands.

I, ASI Kalachand Singha of Khalpara TOP under Siliguri P.S/SPC lodge a written complaint against the above noted person to the effect that today i.e. 28.07.2021 at about 23:15 hrs while performing mobile van duty at Jhanakar More, Siliguri and found that one Shaktimaan truck having Registration No. WB-76/8206 loaded with illegal river bed material, Sands coming from Balasan Colony, Matigara side and going towards Yadav Pally Koila depo, w no- 07, Siliguri. Accordingly myself along with force managed to apprehend the said truck along with its driver and on checking the vehicle and found the truck loaded with sands. On demand the driver Sudeb Pradhan (20), S/O- Sudhansu Pradhan of Patiram Jote, P.S- Matigara, Dist- Darjeeling could not produce any valid or relevant documents in support of said loaded vehicle and he also failed to produce the valid documents relating to the loaded sands in the truck. Hence there was reason to believe that the driver of the truck had procured the vehicle along with its loaded materials illegally and transporting the same for his illegal gain.

On further grilling he discloses that he along with the owner of the truck in association with others of Balasan River Ghats had procured the River bed materials, sands illegally from and carrying/transporting the same to Siliguri side for their wrongful gain without any valid documents.

Under the circumstances, I seized the Shaktimaan truck bearing Reg. no- WB 76/8206 along with loaded sands under proper seizure list and arrested the driver of the truck under proper Memo of Arrest after explaining the reason of arrest to him. The whole process of seizure and arrest took place in between 23:30hrs to 00:30hrs (28.07.2021/29.07.2021).

Under the above, I pray before your kind end to start a case against the above arrested person namely Sudeb Pradhan (20), S/O- Sudhansu Pradhan of Patiram Jote, P.S- Matigara, Dist- Darjeeling and the owner of the seized vehicle under proper section of law and caused its investigation.
