Sir,

In producing herewith six (06) arrested accused persons who disclosed his name and identity as (i) Rahul Mahammad (20yrs) S/O- Md. Saifuddin of Fulbari Murder More, PS-NJP, Dist-Jalpaiguri, (ii) Subash Barman (24yrs) S/O- Panbabu Barman of Baribhasa, 2 No Dabgram, PS-NJP, Dist-Jalpaiguri, (iii) Mintu Mazumder (53yrs) S/O- Haripada Mazumder of Milanpally, near Milan Samity Club, Ward No-25, PS-Siliguri, Dist- Darjeeling, (iv) Mohesh Sahani (24yrs) S/O- Lt. Baijnath Sahani of Tikiapara, Matangini Colony-II, PS-Siliguri, Dist-Darjeeling, (v) Md. Azgar Quareshi (55 yrs) S/O- Md. Gaffur Quareshi of Old Matigara, Road, Siliguri Junction, PS- Prodhannagar, Darjeeling & (vi) Soumodip Halder (23 yrs) S/O- Lt. Probir Halder of 30 P.K. Guha Road, Dumdum, PS-Dumdum, Dist-North 24 Parganas. I, SI Malay Kumar Roy of Siliguri PS/ SPC do hereby lodge complaint against the above noted arrested persons to the effect that, on 29.07.2021 at around 11.20 hrs during my Spl. R/T Mobile Van duty myself along with my accompanied force had been to Fileswari Bazar area, Siliguri and found that the above noted persons were roaming without wearing mask on their face and without any proper reasons.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and all the orders of Government as well as local administrations regarding COVID-19.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021 and Order no- 713-ISS/2M-22/2020 dated 31.05.2021, Order no.753-ISS/2M-22/2020 dt.14.06.2021, 753/II-ISS/2M-22/2020 dated 28.06.2021 and 753/III-ISS/2M-22/2020 dated 14.07.2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the State as well as country. Accourding, I arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
