Respected Sir,

I, Sri Bhaskar Chakraborty S/o Nirmulandu Chakraborty, Superintending Manager Of Sukna Tea Estate, Po -- Gulma , Ps -- Pradhan Nagar Dist- Darjeeling. Beg to lodge this written complaint stating as under: -

1. That today i.e. 27/07/2021 at around 12.30 pm I, along with our Chowkidar Sri Lazrush Barla were proceeding towards our garden plot no 303 LR, khatian no 885 for attending enquiry by the R.I Matigara Block in-connection with PTN no 64/2021. When we reached near the place of enquiry, the aforesaid persons gheraoed myself and my chowkidar with deadly weapon and demanded from me Rs- 03 lakh otherwise they wouldn't allow us to attend the enquiry. When I refused, they started to assault my chowkidar and when I found no other alternative I ran away from that spot and reached to enquiry spot where the other persons of the garden were waiting. There I heard from the chowkidars that Sri Lazrus Barla was badly assaulted by the aforesaid persons and they tore away his shirt. They had beaten the chowkider to pressurize me to fulfil their illegal demand.
2. These miscreants of the land mafia are continually threatening and demanding money from us by telling that if we do not fulfil their illegal demand they would not allow us to run the garden peacefully..
3. They are continuously threatening to murder the garden trade union leaders.

In the aforesaid circumstances I would request you to kindly investigate the matter and bring the culprits to book otherwise it would not be possible for us to run this Tea Estate effectively.
