I, ASI. Biswajit Ghosh of Ambari Falakata OP under NJP PS/SPC beg to report that on 26.07.21 in course of SPL mobile van duty vide Ambari OP GDE No- 889 dated on 26.07.21 myself along with force namely (1) ASI. Ram Prasad Adhikari (2) C/975 Swarup Basak and (3) C/625 Bhabendra Das all of Ambari-Falakata OP, Under NJP PS/SPC had been to Sahudangi More, under Ambari Falakata OP. PS. NJP to perform SPL mobile Van duty at 17:35hrs I found the above noted persons were roaming without face mask at that area and violated the Government Order (Lock Down) in c/w outbreak of COVID-19. Accordingly, the above noted persons were detained. On being interrogation they disclosed their identity as mentioned above and further they failed to give any satisfactory answer regarding their movement in that area rather they refuse to comply with direction of the Government Order regarding lockdown in c/w outbreak of Covid-19. Hence I arrested them u/s 41 Cr.P.C after issuing copy of Memo of arrest and inform their ground of arrest.

Therefore I pray before your good office that a specific case under proper section of Law may kindly be started against the above noted accused persons namely (1) Shivam Saha (18yrs), S/o. Sri. Pranesh Saha of Ambari-Falakata, PO. Kamarvita, P.S NJP, Dist-Jalpaiguri (2) Shankar Roy (22yrs), S/o. Lt. Upen Roy of Thakurnagar, PO. Sahudangi Hat, PS. NJP, Dist-Jalpaiguri and (3). Sajimuddin Md. (50yrs), S/o. Kenu Md. of Haricharanvita, PO. Balaram, PS. NJP, Dist-Jalpaiguri (4) Dipankar Mallick (23yrs) S/o. Dilip Mallick of Madhya Chakiavita, PO.
