With due respect, I am producing herewith the arrested accused person namely Bibhash Datta @ Nantai (32 yrs) S/O Subhash Ch Dutta of Surya Sen Colony, Block A, Bhuttabari, PS-NJP, Dist.- Jalpaiguri under arrest and 01 improvised small Fire arm measuring 20 cm in length from butt to barrel with one trigger, striking hammer, striking pin and one megagine in working condition loaded with 03 round live ammunition seized from the possession of the said accused. The ground of arrest duly been communicated with him. ,

I SI Goutam Mallik of NJP PS, SPC do hereby lodge this written complaint against the arrested accused Person namely Bibhash Dutta @ Nantai (32 yrs) S/O Subhash Ch Dutta of Surya Sen Colony, Block A, Bhuttabari, PS- NJP, Dist.- Jalpaiguri. In this regard I beg to report that today i.e. on 27.07.21 at 22.25 hrs I received a secret information that one person has been seen moving suspiciously at surrounding Ambika Nagar underpass under PS NJP and most probably for committing heinous crime and he possess one small Fire arm with ammunition. Diarised the information vide NJP PS GDE No 1456 dated 27.07.2021 and informed the fact to you. As per kind order and direction myself along with ASI Khagen Barman C/1053 Paresh Rava, VP/13 Jamirul Islam, VP/08 Laxman Roy and CV/306 Bisawajit Roy left for Ambika Nagar under pass to work out the information in hand by Govt. vehicle. We reached at the spot i.e. Ambika Nagar underpass at 22.35 hrs and as indicated by source we able to apprehend one person. We searched him immediately and found 01 small Fire arm measuring 20 cm in length from butt to barrel with one trigger, striking hammer, striking pin and one megagine in working condition loaded with 03 round live ammunition in his possession which he was carrying in his waist concealed underneath the shirt. On interrogation he disclosed his name and address as noted above. He admitted that earlier he was involved in several crimes under NJP PS. He exclusively possessed this improvised fire arm loaded with 03 (three) live ammunition illegally. On demand he failed to produce any document in support the said improvised fire arm which is found in his possession.

Thus when his involvement in carrying and possessing illegal fire arm was established, I scized that improvised fire arms loaded with 03 (three) rounds of live ammunition under proper scizure list duly signed by him as well as by available witnesses between 23.05 hrs to 23.35 hrs on 27.07.21 and arrested him by preparing memo of arrest informing him the ground of arrest.

Under the above noted facts and seizure of incriminating articles there is strong reason to believe that the accused person namely Bibhash Dwtta @ Nantai (32 yrs) S/O Subhash Ch Dutta of Surya Sen Colony, Block A, Bhuttabari, PS- NJP, Dist.- Jalpaiguri is desperate and dangerous in nature, as he was carrying the said fire arm loaded with live ammunition with an objective to commit heinous crime in the locality.

As he has willfully violated the regulation of Arms Act, So, I pray before you for starting a case against the arrested accused person namely Bibhash Detta @ Nantai (32 yrs) S/O a case as Ch Dutta of Surya Sen Colony, Block A, Bhuttabari, PS- NJP, Dist.- Jalpaiguri under Subhash to portion of law and arrange for its investigation appropriate section of law and arrange for its investigation.
