In producing herewith one person namely Suman Tamang 31 yrs s/o Gopal Tamang of MM Tarai PS, Bagdogra, Dist- Darjeeling under arrest along with following articles under seizure, total of 252 nos. viz:

1. 10 (Ten) bottles of Himalyan Gold 60' Up country Spirit (each bottle containing 500 ml.) marked as Exhibit "A" from which 01 bottle randomly taken out as sample and marked as Exhibit "A-1",
2. 04 (Four) bottle COSMOS Fifty (each bottle containing 750 ml.) marked as Exhibit "B" from which 01 bottle randomly taken out as sample and marked as Exhibit "B-1",
3. 05 (Five) bottle King Fisher Beer (each bottle containing 550 ml.) marked as Exhibit "C" from which 01 bottle randomly taken out as sample and marked as Exhibit "C-1",
4. 01 (One) container containing five liters Local Made Chullu marked as Exhibit "D" from which 01 liter randomly taken out as sample and marked as Exhibit "D-1",

I, ASI Jakirul Islam of Bagdogra Police Station, SPC do hereby lodged this complaint against the above noted arrested person named Suman Tamang to the effect that today i.e., on 30.07.21 at 14.25 hrs. received source reliable source information that one person who possessing huge quantity of illicit liquor at his house in the village of MM Tarai and sell the same to his designated customers from his house. Accordingly I shared the information with you and diarized the fact vide Bagdogra Ps, GDE no 1670 Dtd. 30.07.21 and as your kind direction, I along with force had been to MM Tarai under Bagdogra PS, to verify the veracity of the information. On reaching there at about 15.10 hrs, I contacted with my source he point out the house we cordon the house presence of police some customers run to fled away from the house and subsequently we apprehended the above noted person on asked he admitted he run the business since few months and on search of his house in presence local persons as well as him the above noted illicit liquor has been recovered from his house on being asked disclosed his identity as noted above and on demand he failed to produce any valid documents/papers in support of possessing and storing of the illicit liquor on his house. Accordingly, I seized the above noted illicit liquor found under proper seizure list in presence of witnesses and labelled and also arrested him issuing memo of arrest also inform him ground of his arrest. The whole process of seizure and labelled was made in between 15.20 hrs to 15.45 hrs.

Therefore, I pray that a specific case under proper section of law may kindly be recorded against above noted Suman Tamang 31yrs s/o Gopal Tamang of MM Tarai PS, Bagdogra, Dist- Darjeeling and arrange for its investigation.
