This is to kindly inform you that I, Eugene Gwong, resident of PARIJAT ROAD, METHIBARI, P.O. SALBARI, P.S. PRADHAN NAGAR, SILIGURI-2. would like to report an incident of car fraud and theft by HIRAK SINGHA, an employee of Poddar Car World, Fulbari.

On 20/JULY/2021, HIRAK SINGHA, came to my residence and valued my car at Rs. 2,60,000 (Rupees Two lakhs sixty thousand only) with a condition of exchanging the old car for new. He gave me a slip of his company (PODDAR CAR WORLD) for an amount of Rs. 1,60,000 (Rupees One Lakh sixty thousand only). When I asked him why he gave slip of less value then he told me that he will adjust the Balance of Rupees One Lakh (Rs. 1,00,000) in exchange bonus, dealer discount, special discount and accessories to which I agreed. However, as discussed with him when I went to purchase my new car to Poddar Car World on Sat, 24/JULY/2021 to my dismay I learnt that HIRAK SINGHA is not working there since 2-3 weeks. Therefore with the help of the staff of Poddar Car World we went to HIRAK SINGHA house in TABGRAM area his wife Ms. POOJA CHETTRI D/O RUDRA PRASAD CHETTRI permanent resident of HAKIMPARA, SALPAIGURI informed that he hasn't come home for the past 3 days and that she doesn't know anything about this matter.

Then, we frantically started calling his number 7679251175 but there was no response. At, around 5pm he came online on WHATSAPP, then I called him there, the phone was ringing but →

Then I called that number it was of CAR ICONS, SILIGURI belonging to MR. BISWAJIT. Then I immediately contacted went to his given address and found my car at his parking on the road. When I confronted him he said to me to pay 1,60,000 and take the car as he has paid the grandster 1,60,000 and bought the car from him. ~~without~~ When I asked him to show if he had any proof he refused. Now the car is lying in his custody and he said to me to pay and take the car or else he will sell the car to someone else.

Now, my prayer request to your kind self is to kindly help me in this situation and please help me to get my car back. I hope you will consider my case sympathetically and help me.
