With due respect and humble submission, I A.S.I. Ratan Pradhan of Pradhan Nagar Police Station herewith produce 01 (one) accused namely Kanai Roy(36) s/o Lt Bipin Roy of 1 no Panchanan colony, P.S- Pradhan Nagar, Dist. Darjeeling under arrest along with following seized articles under proper seizure list

1. 25 (Twenty five) plastic bottles Himalayan gold 60 up country spirit , each bottle 600 ml

The brief Fact is that on 30th July 2021. myself along with officer ASI Ashit Kumar Singha, and force CV/131 Ranjan Sharma ,CV/128 Ajay Kr Sahani, left from P.S for Special mobile van duty vide PDN PS GDE No. 1841 at about 07.35 hrs. During mobile duty I received an information that one person namely Kanai Roy of 1 no Panchanan colony store huge quantity of illicit liquor in his house which situated at 1 no Panchanan colony under Pradhan Nagar P.S, Dist- Darjeeling and selling the same locally. Accordingly, I share the information to you and as per your kind instruction myself along with force rush to the spot, held raid above noted accused house and detained the above noted person with the help of force and on search of her house recovered above noted articles, On demand he failed to produce any valid document in favor of recovered articles .On interrogation she admitted her guilt and further she confessed that she selling the same illegally without any valid document for her illegal gain. Accordingly I seized & label the above noted articles in between 08.10 hrs to 08.45 hrs and arrested the above noted accused observing all necessary formalities.

Therefore, I pray before you to start a specific case under proper section of law against the arrested person namely Kanai Roy(36) s/o Lt Bipin Roy of 1 no Panchanan colony, P.S- Pradhan Nagar, Dist. Darjeeling and arrange for its investigation.
